

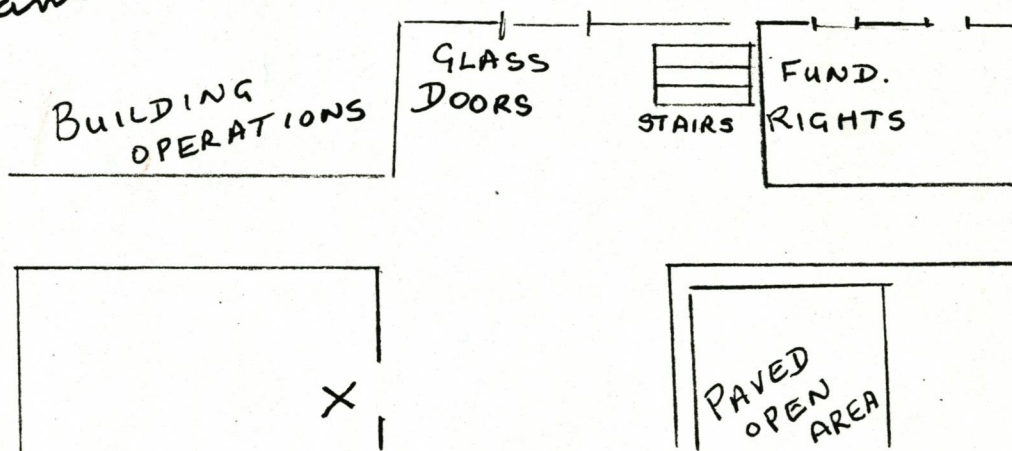



1. Draft Proposed Chapter:

Prof. Hugh Corder asked me to pass the following on to you as an entirely independent suggestion from himself in relation to Clause 7(1)(b):

"(b) bind other persons and bodies effectively performing public functions."

This is if the need arises for another alternative to consider.

2. Ad Hoc Committee Meeting:


