1. Progress report

It was reported that:

a) UNZA

- i) the Vice-Chancellor agreed to invite both the UWC and UPP delegation and to host them;
- ii) he agreed to obtain immigration clearance for them to enter Zambia.

b) Accommodation

Reservations had been made at Pamodzi Hotel.

c) Budget

- i) funding for UWC/UPP delegations was discussed with Cde Mendi;
- ii) he Cde Mendi) advised that the PC should discuss it with PASA Steering Committee;
- iii) SIDA's position as reported by Cde Lindiwe was that PASA funds would be utilised for the delegations.
- iv) the entire UWC trip from Cape Town to Lusaka/Dar would be funded by the Movement;
- v) UWC advance party asked to be reimbursed for the trip they undertook to Lusaka recently;
- vi) suggested that as regards committing the Movement financially, there had to be prior consultation;
- vii) suggested that it was advisable that Wits Admin delegation should fund their trip as they have a good source of funds;
- viii) UPP would be partly funded by the Movement(Lusaka-Dar) except for one student.

d) Venue

Pamodzi Hotel preferred for the meeting.

e) Programme

- i) agreed that meeting with UWC delegation should begin on Sunday instead of Monday;
- ii) agreed that the daily programme meetings should begin at 9.00 with tea-breaks at 11.00 and lunch at 13.30 to resume at 14.00. Programme could include meetings in the evening.

f) Transport

As regards transport to and from the airport and visit to UNZA, it was suggested that:

- i) there had to be a separate meeting about it;
- ii) alternatively, the Security would have to be approached for assistance.



2. Composition of ANC delegation

The composition of the delegation would be in accordance with the UWC agenda. Agreed the following would compose the delegation:

Cdes Thabo, Pallo, Stuart, Chris Hani, Billy, Jack Simons, Vuyiswa Nokwe, Barbara, Andrew Masondo, Miranda, Mohammed, and reps from the Youth Section, Women's Section and PMC. ✓

3. Review of UWC agenda(dated 7/10/87)

- i) agreed that items on UWC, colleges and schools should be merged and the rest concerned teachers organisations;
- ii) it was pointed out that item on inter-ethnic attitudes should be approached with care;
- iii) agreed that Cde Billy would reformulate UWC agenda;
- iv) agreed to approach the PMC for someone who specialised on the Western Cape to assist with briefing and to discuss UWC agenda with the Education Secretariat;
- v) Cde Thabo would assist with briefing on academic boycott;
- vi) Cdes Pallo and Mohammed to assist with information package for the ANC delegation.
