Comrade Rica Hodgson

Correspondence between yourself and Cde Rica Hodgson concerning her intention to join Cdes Chandia and Spencer when they transfer to Zimbabwe has come to my attention.

I gather that from the viewpoint of the ANC as expressed by the Secretary-General, there is no objection to Cde Rica's request. The problem appears to be how she can legally enter Zimbabwa (as an immigrant?).

I have no experience in these matters and I expect you would know better. I do have a feeling that there would be considerable redtape if the question were to be tackled as a straight case of immigration. The best way out seems to me to be for Cde Rica . come under the "umbrella" of her children (Ckaadia and Spencer) as a dependant. I don't know whether this is possible and whether Cde Rica would approve such arrangement considering her independence. Questions of obtaining residence permits could probably be sorted out when she shall have arrived in Zimbabwe.

It would be interesting to know when Cde Spencer is expected in Zimbabwe and I trust by now you have some information from Cde Jaya?
