NATIONAL EXECUTIVE COMMITTEE ADDRESS BY THE PRESIDENT

3 NOVEMBER 2008 DURBAN

There is no doubt that we are right in the middle of the 2009 election canvassing. | again wish to congratulate our National Chairperson and her teams who have been canvassing so vigorously with her. | admire her enthusiasm and vision, which underscore the proposals that she made here concerning the programme. But it seems as if there is really some validity in the Chairpersonâ\200\231s suggestion that our opponents seem to have a copy of her itinerary. The way the ANC seems to be marking her steps wherever she decides to go, confirms that speculation.

The way the ANC leaders have decided to use the  $\hat{a}\200\234$ Zumamania $\hat{a}\200\235$  that seems to have got some people, confirms the rumour to the effect that there is definitely no doubt that what we read in the print media, that the ANC is determined to use Mr Zuma in order to gain the 60 per cent win in KwaZulu Natal that they have constantly claimed they will achieve in the 2009 general election, is true. But the emergence of the Lekota-Shilowa initiative may not necessarily mean a threatening and serious split in the ANC. But, on the other hand, the dismissive attitude that Mr Zuma seems to adopt in speaking about it, may end with Mr Zuma being surprised by the extent to which it has affected the ANC. And on the other hand, there are these rather strange emissaries who are waving olive branches at us. My gut feeling is that this thing which the ANC is doing is evil and is meant to bury us as an entity in the South African body politic.

For some months in the past | have expressed my concern that we are too relaxed and office-bound. | do not know what to suggest now about some of our leaders, particularly representatives at all levels, such as Members of Parliament, Members of Legislatures and Members of Municipal Councils. If these people are not already in the forefront of our electoral campaign, | cannot see what reason we have even to dream of taking back the Province and increasing our support in other Provinces. | know that there is a view which some have expressed that maybe we should spend most of our energy and money trying to win back the Province and avoid spreading ourselves too thinly throughout the territory of South Africa. | see that there is some merit in this kind of argument.
