RE: SOUTH AFRICAN EXILE STUDENTS IN THE UNITED KINGDOM The Luthuli Memorial Trust (LMT) presents its compliments to the High Commission for the Republic of Singapore in the United Kingdom (the High Commission) and has the honour to submit the following request to the High Commissioner: The LMT is an autonomous or independent educational Trust registered in the UK as a Charity. The LMT was established in the UK as such Trust by the African National Congress (ANC) in March 1982, For the purpose of raising Funds for the education of black South Africans who had been denied normal education by the apartheid regime. The belief was (and is) that it was essential For us to train or educate as many Africans as possible, in all fields of learning, in order to ensure that Africans would play a meaningful part . in the governance of a post-apartheid South Africa. This remains our mission. It is more urgent now than ever before in view of the current political developments in South Africa which bode well For the end of apartheid. We need every educated person we can get, urgently.

The LMT has been informed by the leadership of the ANC in Johannesburg, South Africa that the delegation of the Government of the Republic of Singapore to the meeting of Commonwealth Prime Ministers and Heads of States held in Harare, Zimbabwe, in October 1991, informed the ANC delegation headed by President Nelson R Mandela that the Government might be able to assist ANC-sponsored projects, especially in the field of education. We were, therefore, advised by the ANC leaders to approach the Government with a request for financial assistance for our programme.
