A powerful speech was delivered by Peter Mahlangu (SACTU Rep.). Vuyo: Her and Janet Halpin (MCOAA) had made a presentation on South Africa at the United Church service in Winnipeg on June 5th. She attended the Aug. 9th S.A. Women's Day Committee meeting. The meeting was held on July 7th. Vuyo was also working on a paper which she was to present at a workshop in Lusaka at a later date.

Lindy: Had spoken at a United Church meeting in Stonewall, coincidentally, the same day the state of emergency was renewed in S.A. It was a good meeting and as a result, the group had proposed to hold a study session on S.A. for a period of one year. She had also attended the SOWETO Days event of June 16th. She reported that the June 26th event - Freedom Charter Day was poorly attended, however, the overall view of the freedom charter was presented. An excellent presentation. Re: S.A. Women's Day Committee held ameeting on July 7th. Instead of August 9th, the event was to be held on August 6th. Formt of the evening: - a 10 minute video presentation, 'women awake' - dinner, -speaker followed by entertainment.

Reports continued: Lindy:- had attended MCOAA meeting of July 6th at which a video "Disinformation by S.A. embassy" was shown. Janet Halpin had received a phone call from the department of external affairs (Ottawa) requesting MCOAA representation at a meeting to be held on July 13th to discuss ways and means of counteracting the disinformation propaganda by the S.A. embassy.
