INTERIM MEASURES FOR LOCAL GOVERNMENT ACT_NO. 128 OF 1991

Sirs

I believe it is pertinent that CODESA reviews the Government's sincerity regarding negotiations in the light of the Interim Measures for Local Government Act No. 128 of 1991.

In the spirit of democracy, local communities are requesting that members of racial structures resign in order to prepare for a new dispensation for loca. government. All over the country, apartheid structures have either collapsed or are willing to dissolve themselves and want to negotiate with progressive structures. Some members who have seen the light, have voluntarily resigned and joined hands in unity with their local communities but certain Town

Councils, their surrogates and Provincial Administrators are slavishly adher to existing practices and are striving to maintain racially constituted

structures against the wishes of the people. Unilateral decisions are taken and nominations are made in order to maintain the status quo. This 1s totall

in contradiction to the spirit of CODESA.

CODESA needs to urgently demand that the Government repeals the Interim Meas for Local Government Act No. 128 of 1991 immediately in order to display the determination and sincerity to negotiate in trust and goodwill.

A very disturbing factor is the Government's call for an all-white Referand It is clearly indicative that they are truly not committed to the negotiati

plan but are using any avenue to remain in power. There is a dire need to t their motives and everything must be done to discover whether they do not h another agenda up their sleeve.

It is imperative that CODESA draws up its own Interim Measures for Local Government that uphold the principles of democracy. Guidelines need to be \hat{A} to all structures. Local communities must be permitted to dismantle racial] structured Committes if general consensus exists.

The Government, in passing its Act, is trying to put its own bias version

of local government in place to pre-empt the outcome of national negotiations

CODESA further needs to urgently take note that while the Act is called "interim" the structures which could be set up in terms of the said Act may be very difficult to dismantle at a later date. Local authorities are only woodwinking the people on the ground under the guise of democracy in order to set up structures in terms of their own policies. The Government is trying to change local government now, before we have negotiations about a new constitution for the country. It is because they want to keep privileges tha their supporters have, even when we have a "New South Africa".

The Act has no guiding principles such as democracy and non-racialism to gui the restructuring of lecal government.

The Act tries to solve the problem of restructuring local government from top down. It allows for the setting up of negotiating forums by discredited racial structures. The Provincial Administrator has the power to appoint a mediator, decide who should represent the community, and approve the final agreement. It is distressing to see how they strive to keep their lackeys ir Office against the popular demands of the people. Management Committees have the right to block any agreement that does not favour them. Is this the type democracy we are busy negotiating?

Two or more â\200\230local bodies' can meet together and draw up an agreement to me: into one new body. The problem is that this can be done without any consultation. This will mean that even if a new council is non-racial it wo be accountable to all the people in a town or city. For this reason I am saying that the Act produces undemocratic structures.

To improve the present system of local government, I would suggest that COD. take cognisance of the South African Law Commission Report on Constitutiona Models, regarding the following issues:

- 1. The re-integration of South Africa's divided cities and towns, steering development away from a dispersed and racially divided growth pattern to a more compact accessible and productive urban system.
- 2. The $\hat{a}\200\234$ opening up" of all cities to afford equal opportunities and access all facilities and services in the urban areas.
- . 3. A new urban and rural financial strategy designed to make maximum use 01 the available resources and to develop them.

- 4, An effective housing policy including financial assistance to the poor to enable them to acquire land, and the rendering of services.
- 5. The provision and creation of employment.

Finally CODESA needs to expound a vision of how resources could be expanded in future, and how they could be used more efficiently and democratically.

I wish you successful negotiations and sincerely hope that all parties call for consolidation of separated black and white authorities into single non-racial councils with a single, unified tax base, serving as acceptable local governments in a non-racial, non-sexist, democratic South Africa.
