DRAFT RAPPORTEUR'S REPORT OF THE FOURTH ORDINARY SESSION
OF THE CONFERENCE OF AFRICAN MINISTERS OF HEALTH
I. OPENING

The Fourth Ordinary Session of the Conference of African Ministers of Health was held on Monday 29 April, 1991, at 8:25 a.m. in Mbabane, Swaziland, under the Chairmanship of H. E. the Minister of Health of Uganda, in the presence of His Majesty King Mswati III of the Kingdom of Swaziland.

- 2. The Conference also heard statements by:
- (1) WHO Regional Director for Africa (AFRO);
- (ii) WHO Director-General
- (iii) OAU Assistant Secretary-General;
- (iv) His Majesty King Mswati III, who officially opened the Fourth Session of the Conference of African Ministers of Health.
- 3. Copies of the statements are attached to this report.
- 4. All the speakers stressed a number of issues including the timeliness of holding the meeting as it coincided with the Decade for Child Survival, Protection and Development and the International Decade for Natural Disaster Reduction, the linkage of the health sector to development and the need for Member States to accord health sector top priority.
- 5. The first three speakers also thanked the King, Government and people of the Kingdom of Swaziland for hosting the Meeting, the excellent arrangements made and measures to ensure the success of the Meeting and for the generosity and the typically African hospitality extended to the the delegations.

- 25. The establishment of a central pool for the purchase of drugs was introduced by one delegation. The Secretariat was asked to coordinate . with the Ministry of Health of that delegation. The consensus of several members of the meeting was that essential drugs was a complicated issue. Paragraghs 126-129
- 26. Several delegates expressed the view of formulating a directory of volunteer experts from Member States, so as to facilitate easy contact. Paragraghs 130-135
- 27. The importance of screw worm fly as a killer fly of human beings, cattle and wild life was stressed. Recommendations were made for a regional strategy for monitoring and controlling the screw worm fly in cooperation . with international organisations like the FAO.
- Agenda Item 6: Matters of Interest to Member States on the Provisional Agenda of the Fourtz-fohfth Session of the Herld Health Assemblz
- 28. The Chairman introduced the Agenda item and referred the delegations to the decision of the Experts to defer the consideration of that item to the Meeting of Ministers.
- 29. After reaction from a delegate on the criteria for selection of

those matters of "interest", the representative of the Secretary-General reminded delegations of the regularity of that agenda item at previous Conferenses of African Health Ministers as a means of forging a common African position on matters that are to be discussed at the World Health Assembly.

- 30. At that juncture, the WHO Regional Director for Africa gave a brief overview of the items of interest on the Draft Agenda, even though he agreed that all items on the Draft Agenda affect Africa, even though sometimes some are of special interest as those discussed during the Third Conference of African Ministers of Health in Kampala. He also clarified . a few of the items and reminded delegations, those in arrears to pay and that AFRO is designing a method of assisting those Member States in arrears. Agenda Item 7: An: Other Business
- 31. The Conference heard a presentation from the delegation of Chad on the Socio-political and Natural Disasters that the country and people are going through now, that have disrupted the economy and food production in the country. Hence Chad is pleading for a "Resolution on Drought, Famine and Food Situation in Chad" for which the delegation expected full support. 32. In the ensuing debate, delegations supported Chad's plea and requested the Secretariat to support through her Special Emergency Fund . for Drought and Famine in Africa. The representative of the Secretary-General reminded distinguished delegates that the Fund is there only on paper with no finances because there was no replenishing from Member States after the initial subscription.
- 33. The Meeting noted Chad's concern and directed the Secretariat to draft a resolution on the problem facing Chad.
- 34. On the issue of WHO document that has been circulated to about 30 Member States and which was originally introduced by Uganda in the morning session and referred to _by Namibia in the evening, it was decided that the document goes through the OAU procedure and that African Ministers

of Health should discuss it at the Africa Club in Geneva when attending the World Health Assembly.

Agenda Item 8: Date and Venue of the Fifth Ordinarz Session of the Conference of African Ministers of Health.
