Dear Friends:

As many of you know the Amandla Tour of Montreal-Ottawa-Toronto scheduled for October 1984 was cancelled, with less than six weeks notice, when our tour partners in New York and London decided they could not host and support the group in their own cities. Canada, unable to suddenly come up with an extra \$20,000 to \$30,000 in travel fares to bring the group directly from Lusaka to Canada, had to cancel as well.

It was not a pleasant decision; hundreds of people had been involved at this point preparing three large concerts and a host of outreach activities. Thousands of dollars had already been spent to prepare publicity materials, reserve halls, hire technical experts and send around annoucements.

It was one of the largest cultural projects in the solidarity and NGO community. The support and help preparing for the group (as well as donations and committments of more than \$30,000) proved it could be done professionally, and could be economically feasible.

However, the decisions taken outside our own country proved to be too much to cope with. There was no other decision but to cancel. Attempts to re-schedule Amandla for the spring of 1985 also proved impossible when we could not reach solid and binding agreements with the other potential tour countries.

We hope you will understand that the cancellation of this project will not mean the end to all our work against the evils of apartheid, and towards increased solidarity with our oppressed friends in Southern Africa.
