As the item was straightforward conclusion was reached without much debate, as such the adoption of document ID/B/C.3/W32.

However, a request was made to the Secretariat of the IDB to further strengthen its role in accordance with resolution 11 on UNIDO's co-ordinating role in the United Nations system on industrial development adopted by the Fourth General Conference of UNIDO.

On item 5, which dealt with evaluation, Speakers agreed and stressed the necessity to continue efforts to improve the system and also urged that UNIDO extend its use to other areas, such as policy, co-ordination, research and UNIDO's system of consultation. The Committee also re-emphasized the importance of participating States in the evaluation process.

the establishment of our Workshop at Mazimbu, and being told that he was due to leave for Tanzania the next day, I was also informed that equipment worth US 60,000 out of the allocated Z'9#,000 for the project, had already been purchased and shipped to the port of Dar-es-Salaam.

It will help in producing trained personnel in planning, operation and management of repair and maintenance works.

Mr Chairman, this kind of support not only serves to alleviate the burden in our host countries, but also helps to provide a meaningful life for our people. My delegation therefore calls upon UNIDO to also consider giving us assistance in the establishment of similar projects elsewhere where we have settlements, such as is the case of Tanzania.

In conclusion I find it worthwhile to note that, our very participation in such meetings as the current session of the IDB serves to broaden our perspectives of the immense task facing both our movement and our people.

We would therefore express hope, Mr Chairman, that as you will follow and evaluate the progress of this project through your competent staff, the balanced judgement of your assessors will give you further strength, despite the limited resources, to find the necessary means to give continued assistance to our constrained efforts in what we believe is a passing phase in the life of our long-suffering people.
