This letter is a follow-up on the Dinner you and others attended in honour of Nelson Mandela at the Commonwealth House on the 3rd July last. It is concerned not with policy questions that Mr. Mandela addressed on that occasion, but with matters educational.

I need hardly labour the point that post-apartheid South Africa will inherit a legacy of educational backwardness amongst Africans. This will make it difficult for Africans to participate meaningfully in the governance of a free society. There will be a serious shortage of skilled personnel in every sector of the economy - Agriculture, Industry, Science, Technology, Transport and Communications, Management, Administration etc. In order

to address this problem, the African National Congress (ANC) established the Luthuli Memorial as an autonomous charitable Trust under English law to help train as many Africans as possible for the day when fundamental political changes come to South Africa. It is fair to proceed on the Footing that that day is now not very far distant. The need for training is, therefore, much more urgent than it was in previous years. The purpose of sending you the enclosed documents is to enable you to get some idea of the nature and extent of the educational needs of our people and to give them such assistance as you can. Any help you can give will be greatly appreciated.
