

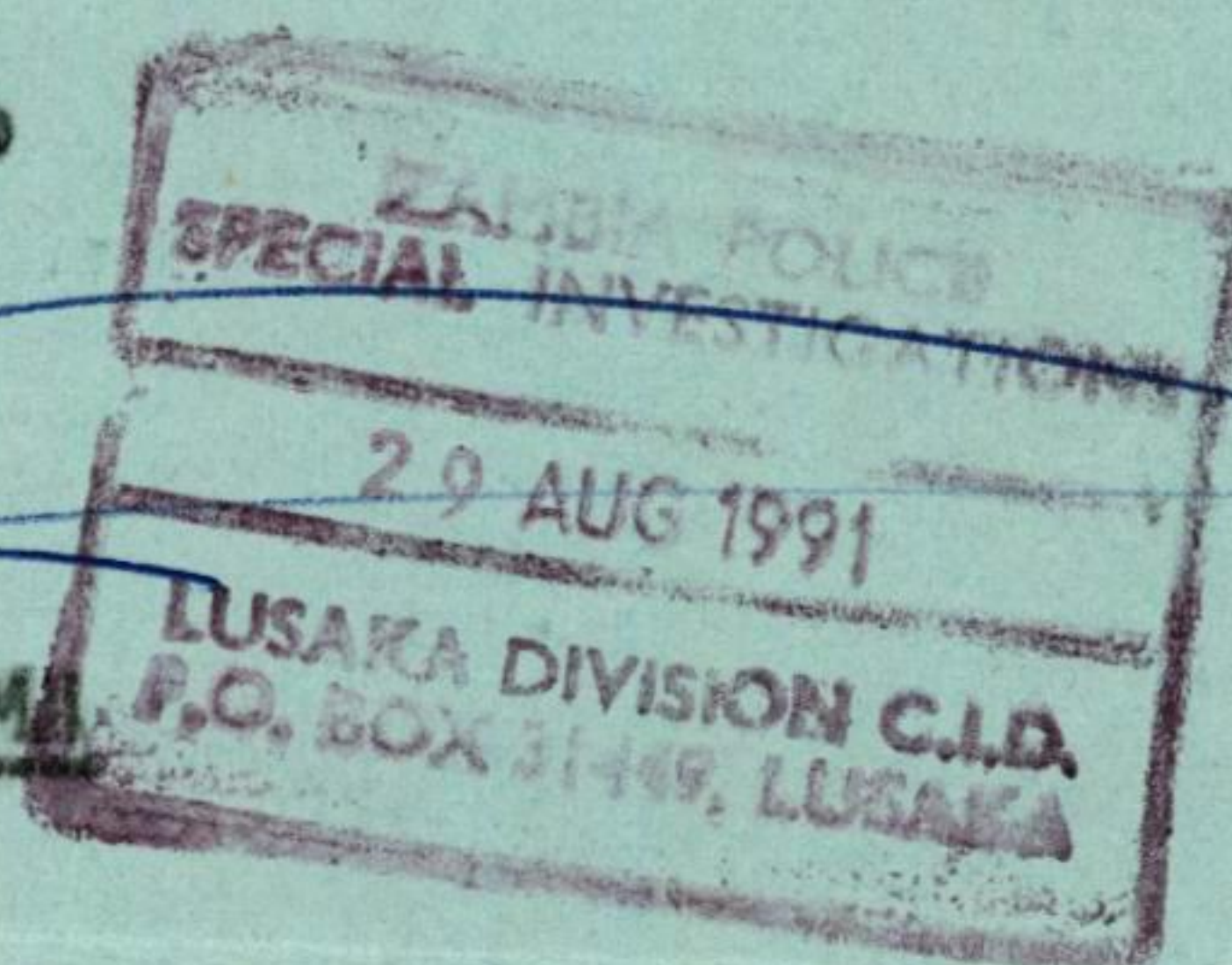
I hereby apply and seek assistance to secure and buy one of A.N.C. House formerly occupied by A.N.C. Cadres, in Ntendere Compound.





