#### Malema defends his lavish lifestyle

IT WAS nobody's business where he got his money from – and his supporters did not mind his lavish lifestyle, ANC Youth League leader Julius Malema said yesterday.

"One of the things I've learnt in my short life in politics is the ability to live in the conditions of capitalism while fighting it and defeating it," he said in Johannesburg.

Malema called the media briefing to respond to a Sunday Independent report at the weekend that he was building himself a R16-million house in the posh Sandown suburb.

He began by saying the news report only existed in "the imaginations of rightwing, narrow-minded and obsessed white people".

Then he told a journalist who asked where he got his money from: "It's none of your

business ... you must mind your own business."

He was a private citizen and not accountable to the media, the youth league president said.

If the SA Revenue Service (Sars) were to investigate him about the reported Sandown house, following a complaint from the DA, he would co-operate fully.

He added he was confident his taxes were in order, before launching into an attack against "ruthless capitalism".

"If you are a capitalist, you are an exploiter."

Asked how he justified his own expensive lifestyle – he lives in Sandton and drives a Mercedes-Benz – Malema responded that poor people did not mind if their leaders were rich.

He boasted that he was "the only remaining leading politi-

cal figure in the country who was welcomed in the squatter camps".

"In this country, there are some among the poor who are saying Cyril Ramaphosa must be the president. He's a multimillionaire.

"Some among the masses are saying Tokyo Sexwale must be president. He's rich. They don't care about his money, our people don't care about our money. What they care about is political consciousness, the will to liberate them," said Malema.

"It's not about where we stay Our people know that very well. It's not about the type of shoes we wear. That is petty. Our people want the political will and the ability to act and that is what we are doing."

Malema said he considered himself to be poor, because his

house in Sandton and his car were owned by the bank.

"My definition of rich is those who own the means of production, I do not own... Instead of being rich, I remain poor, but I'm creditworthy.

Negative media coverage of him was all part of a drive to undermine the agenda he represented.

"I represent nationalisation of mines, expropriation of land, decentralisation of development, free education, the liberation of the working class."

The ANC Youth League would only meet the Chamber of Mines to discuss nationalisation if the chamber agreed to hold the meeting in a poor rural village, so that the mining bosses could "appreciate where we're coming from", he said. – Sapa

#### No word yet on Sutcliffe's job

THE African National Congress-led eThekwini municipality was likely to advertise the municipal manager's post soon but there is no word yet on the future of the incumbent, Michael Sutcliffe

The often controversial Mr Sutcliffe's contract ends at the end of this month. After that his contract is to be extended on a monthly basis, for a maximum of six months. Mr Sutcliffe was deployed to the position by the ANC in 2002.

"We have agreed not to comment whilst we are in discussions," Mr Sutcliffe said in reply to Business Day questions about his future.

DA caucus leader in the city Tex Collins said the post would be advertised and there was nothing to stop Mr Sutcliffe from reapplying.

However, Mr Collins said Mr Sutcliffe had made "some glaring errors" as municipal manager including asking the city council to approve additional funding for the loss-making uShaka Marine Park, and the building of the Moses Mabhida Stadium, which Mr Collins believed was a "white elephant".

The Inkatha Freedom Party's eThekwini spokesman, Mdu Nkosi, said it was just as well Mr Sutcliffe was around for another six months, as he had failed to properly answer

the auditor-general's queries on R532m of alleged irregular spending in the 2009-10 financial year.

Mr Nkosi said tender procedures appeared to have been abused.

Mr Sutcliffe has previously said the irregular expenditure had largely been due to the municipality using its own funds to complete the construction of houses, while still awaiting funding from the province.

Co-operative governance and traditional affairs MEC Nomusa Dube in March this year ordered a forensic audit into the municipality, that would include investigating the roles of Mr Sutcliffe and former mayor Obed Mlaba, in relation to the nondisclosure of interests by councilors and officials, the alleged rental and sale of low-cost houses, alleged irregularities in allowances for travel and overtime and in the appointment of staff, among others.

Mr Nkosi said that while Mr Sutcliffe had launched many significant inner-city projects as municipal manager, rural areas had been neglected, which was a problem because about 60% of eThekwini consisted of rural communities.

## Pressure builds for Zuma to act on Cele

PRESSURE is mounting on President Jacob Zuma to act against his police commissioner, Gen Bheki Cele, and Public Works Minister Gwen Mahlangu-Nkabinde after damning findings by Public Protector Thuli Madonsela on two lease deals involving the South African Police Service (SAPS).

Mr Zuma has not commented on the findings since the report was made public last week. Through his spokesman, Mac Maharaj, Mr Zuma said last week he would allow government processes to take place before making any decision.

It is understood Mr Zuma has handed the document to his legal department before presenting it to the Cabinet. Cabinet spokesman Jimmy Manyi was not able to say whether the reports would be tabled at next week's Cabinet lekgotla.

Releasing her findings on the investigation into the SAPS Durban building lease last week, Ms Madonsela found Gen Cele and Ms Mahlangu-Nkabinde's conduct to have been improper and unlawful and said it amounted to maladministration. She made the same findings in a previous investigation into a lease deal for the SAPS headquarters

in Pretoria. Both deals involve businessman Roux Shabangu.

Ms Madonsela recommended Mr Zuma take action against those implicated. Gen Cele's planned press conference to respond to allegations contained in Ms Madonsela's reports was called off twice this week.

The Democratic Alliance (DA) yesterday said Mr Zuma's delay in taking action against Gen Cele and Ms Mahlangu-Nkabinde undermined democracy. DA MP Dianne Kohler Barnard reiterated her party's call for Mr Zuma to fire the two. "Each day that the president fails to take action represents a further erosion of the values on which our democracy is built."

She said the DA was concerned about comments attributed to Mr Manyi yesterday. He was quoted as saying as far as the government was concerned, the people implicated in the reports were "innocent", and lambasted Ms Madonsela for releasing the reports to the media before they were tabled in Parliament.

This week ANC secretary-general Gwede Mantashe was critical of Ms Madonsela, saying her release of the reports to the public before handing them to Mr Zuma had created "serious problems". shobas@bdfm.co.za

## Malema cries foul over scrutiny of finances

AFRICAN National Congress Youth League president Julius Malema yesterday cried foul, saying the latest public scrutiny of his personal finances was unfair because he was not a public representative.

This was Mr Malema's attempt to defend himself as calls mount for authorities to investigate his financial affairs following reports that he is building a R16m mansion in the northern suburbs of Johannesburg.

Mr Malema was defensive yesterday when quizzed by reporters about the mansion, his income and business interests. "It is none of your business. You must mind your own business," he said.

The Democratic Alliance (DA) and the Freedom Front Plus have approached the South African Revenue Service to conduct a lifestyle audit on Mr Malema.

Mr Malema said he was not obliged to reveal his income and business interests. "I belong to a civil society organisation. I do not have access to public resources. The people you should ask (those questions) are people with access to public resources," he said.

"I'm not accountable to you (the media). I'm accountable to the 5 000 people who elected me in Gallagher (Estate in Midrand)."

DA MP Dianne Kohler Barnard said Mr Malema had to account to the public as he was a public figure. "If he was a member of parliament I would be able to look at his business interests in the registrar of members' interests," she said.

Mr Malema yesterday admitted owning a business which he referred to as a "small entity".

However, he denied he was building a R16m house and claimed the allegation was being made to divert attention from the youth league's calls for the nationalisation of mines and the expropriation of land without compensation.

#### Zapiro taken to task over 'shower Zuma'

THE CONTINUED depiction of President Jacob Zuma with a shower on his head in cartoons has "saddened" the Commission for the Promotion and Protection of the rights of Cultural, Religious and Linguistic Communities.

"It is culturally, religiously and linguistically unprecedented to attack each other on the basis of a forgiven past," the commission's chief executive, Pheagane Moreroa, said in an open letter to cartoonist Jonathan Shapiro, or Zapiro, as he signs his cartoons.

"This type of gutter attack on a president duly and democratically elected by a hand-some majority of the people of South Africa does not contribute to nation building and social cohesion, which is a constitutional ideal."

The commission has also taken issue with Shapiro's cartoons depicting Zuma prepar-

ing to rape "lady justice".

Shapiro said yesterday that he viewed the issue in a different light.

"I am outraged by the unethical actions and statements of Jacob Zuma in his insatiable pursuit of power.

"It was those words and actions that prompted me to produce an image which I know is shocking, but was so important to the whole nation that I felt public interest far outweighed the sensitivities that could be bruised by the cartoon," he said of the cartoon depicting Zuma preparing to rape "lady justice", published in the Sunday Times on September 7, 2008.

It was published in the context of Zuma's looming trial on corruption charges, which were eventually dropped, and threats by his allies that there would be "anarchy" if the case continued. – Sapa



### Ministers are running inflated car hire tabs, says DA MP

MINISTERS are being taken for a ride - literally and figuratively.

Disclosures by seven ministries on their car hire costs have revealed that the departments have been paying inflated prices for cars hired, according to DA MP Ian Ollis.

Over the past 12 months, taxpayers have borne the cost of R1.5 million for car hire for the ministries that have replied to parliamentary questions about car hire so far.

Ollis said the amount was "unacceptable" and raised questions about how the ministers concerned had rim up such large bills.

The DA has posed questions to all 34 ministries about their use of hired cars. Twenty-seven ministries have not responded.

"The DA is also troubled by the disdain for accountability shown by the majority of ministries, given that the majority have failed to reply," Ollis said.

The responses from the ministries that had obliged, he said, were concerning as

the information suggested they were paying rental rates far above the market rate.

Ollis said Minister of Public Enterprises Malusi Gigaba - who in a parliamentary written reply said that his department had forked out just over R200 000 on car hire in the past year - had hired a VW Touareg for one day at a cost of R13 328. The market-related daily rate for such a vehicle was R3 291, said Ollis. He said his office had contacted three of the biggest car rental companies for their price lists before making comparisons.

Arts and Culture Minister Paul Mashatile hired a Mercedes-Benz E Class for two days at a daily rate of R5 891 but the market rate, as indicated by the three companies contacted by the DA, was R2 130, said Ollis.

Ollis said the DA had submitted follow-up questions to the relevant ministers requesting an explanation for "discrepancies such as these".

The DA would also ask which car hire companies had been used and why they had been chosen, seeing their rates were so much higher than

those of their competitors.

"We are not against ministers hiring cars for legitimate government work. Our concern is that there might be corruption regarding the companies providing the services because the prices are excessive," Ollis said.

The government is in the process of tightening up rules for ministerial benefits like travel, car hire and accommodation with the review of the ministerial handbook, but the process has dragged on for more than a year.

## Hawks get green light to arrest MEC

NATIONAL prosecutions boss Menzi Simelane has given the Hawks the green light to proceed with the arrests of KwaZulu-Natal MEC Mike Mabuyakhulu and legislature Speaker Peggy Nkonyeni, as well as yet more suspects in the latest round of the politically explosive "amigos" prosecution.

The execution of the warrants of arrest for Mabuyakhulu and Nkonyeni were postponed from July 8, for the charge sheet to be completed and for new suspects to be joined in the case.

Yesterday, NPA spokesman Mthunzi Mhaga confirmed that Simelane had been briefed by his prosecutions team on Tuesday and that the team was ready to proceed.

"The outstanding processes have been completed, so now the

matter has been handed over to the Hawks. We are done with our part. Hawks, it's up to you," he said.

It is not clear when the arrests will be executed or how many others will be joined in the case.

At least two other officials, believed not to be elected public representatives, appear to be in the Hawks' sights.

Hawks spokesman McIntosh Polela would not comment on the impending arrests yesterday.

In a statement on July 14, the NPA explained why the two arrest warrants, signed on July 4 by provincial prosecuting head Simphiwe Mlotshwa, and due to be executed by the Hawks on July 8, had been placed on hold.

It was felt that additional individuals should also be arrested along with Mabuyakhulu and Nkonyeni, and that the NPA

'should complete the relevant charge sheet first, it said.

News that the arrests would follow after a nearly three-week delay came in the wake of Mabuyakhulu's lawyer's letter to Simelane, which complained that his constitutional rights were being infringed and his rights to a fair trial were being undermined because of the way the matter was being handled.

The MEC effectively told the NPA to either charge him or shut up, taking exception to the public comments about his impending arrest made by prosecuting officials, while he remained in limbo, neither under arrest nor aware of the charges against him.

Mhaga would not directly confirm receipt of the letter, only saying: "It is never our policy to comment on any interaction or

correspondence we have with legal representatives of any individual, hence we are not at liberty to comment in response to your query".

Nkonyeni's office meanwhile said she had not departed yesterday for London to attend the Commonwealth parliamentary conference, as had been expected.

Her spokesman, Wonder Hlongwa, said she still intended to attend, but her departure had been delayed by work commitments.

Nkonyeni and Mabuyakhulu, and the others to be arrested with them, would join former provincial Treasury head Sipho Shabalala, Uruguayan businessman Gaston Savoi, and former Health Department head Busi Nyembezi, among others, in the dock. The case is set to continue in the Pietermaritzburg High Court early next month.

THE celebration of former president Nelson Mandela's 93rd birthday saw South

Africans from all walks of life coming together to honour his legacy.

Ordinary people, politicians, business people and celebrities joined hands and heeded the call that they should use 67 minutes of their lives to express some goodwill towards their less fortunate compatriots.

These expressions of goodwill were done in honour of the man seen by the world as a symbol of commitment to forgiveness, reconciliation, compassion and peace.

But while the world was responding to the call to honour the man described by many as an icon, questions were also raised about how the responses to the call were undermining his role as the militant revolutionary who took arms to fight the apartheid regime.

The questions raised were about how initiatives like the 67 minutes in honour of Mandela are failing to

address the quest for the fundamental changes that Mandela and many other revolutionaries have fought for. In their failure to do so, the initiatives are unfortunately undermining the ethos that, for example, drove Mandela to declare that: "The struggle is my life".

The struggle that Mandela spoke about was against land dispossession, poverty, lack of human dignity, structural inequality and economic exploitation of the oppressed majority. It was a struggle driven by an understanding that the apartheid social relations needed to be overthrown.

As Professor Sipho Seepe has pointed out in his critique of how Mandela should be honoured and remembered, any initiative that steers clear of confronting these fundamental challenges runs the risk of trivialising the man's legacy. So, it is important that in honouring him we assess whether these anomalies have been redressed;

and if not, how we can qualitatively contribute towards the redress.

Our assessment must be based on an understanding of the impact of apartheid and colonialism and how these have come to determine the extent to which the politically free majority can enjoy the fruits of their liberation.

It is common knowledge that South Africa became a majority state after 1994, wherein the majority of its citizens have the right to vote. But it is also common knowledge that the acquisition of political power has not led to the economic emancipation of its majority citizens. South Africa, as former president Thabo Mbeki once said, remains a country of two nations—where the poor majority is black and the rich minority is white.

These, unfortunately, are some of the challenges that post-colonial societies often find themselves. What then becomes important is the mechanisms put in place to

tackle these persisting anomalies.

On its part, the government has made several interventions, including the adoption of policies aimed at opening up opportunities for the marginalised to be incorporated into the mainstream economy.

In doing so, they have acknowledged that the situation cannot be redressed by pretending it is business as usual. There are impediments as to how much the government can achieve in its drive to create an egalitarian-society.

The history of any struggle for liberation has taught us that building alliances and solidarity is a sure way of mobilising forces to challenge such impediments.

What history has also taught us is that such impediments cannot be challenged with superficial solutions that deal with symptoms rather than causes.

What we need are not solutions that (like many charity initiatives) enable those who remain the vic-

tims of marginalisation and poverty to cope with their situation.

What we need is the kind of solidarity that Mandela and other heroes of the liberation struggle had built with the people to challenge apartheid and colonialism.

As Kenyan activist Firoze Manji says, this is the kind of solidarity that "establishes cooperation between different constituencies on the basis of mutual self-respect and concerns about injustices suffered by each".

"It is about taking sides in the face of injustices or the processes that reproduce injustice. It is not built on sympathy or charity or the portrayal of others as object of pity."

What differentiates this kind of solidarity from the limited expressions of goodwill that we display during our "67 minutes in honour of Mandela" is that it does not reproduce the social relations that perpetuate inequality and the injustices faced by "the less fortunate in our society".

Building such solidarity is the greatest honour we can pay Mandela.

Madonsela met Sisulu last week, said his spokes-



"The Speaker has been assured by the minister of police that a security assessment will be done with regard to the public protector, and he will report in due course," Naidoo said.


She said they had discussed "recent events,

Madonsela has recommended that the police minister consider disciplinary action against Cele and other SAPS officials involved in the deals.

Mahlangu-Nkabinde, who is also yet to respond to Madonsela's findings that she acted improperly, including failing to co-operate with the investigation, is in mourning following the death of her brother.

## Cele's 'monkey' jibe highlighted at hearing

Extraditing Dewani would be oppressive, court told

ATIONAL police commissioner General Bheki Cele's comments that Shrien Dewani was a murdering "monkey" was put under the spotlight again during the 31-year-old's extradition hearing in London yesterday.

ewani's lawyer, Clare Montgomery QC, told the Belmarsh Magistrate's Court that Cele's statement had prejudiced her client as it had passed guilt on him.

She said Cele's statement was designed to put pressure on Dewani to return to South Africa and had had an effect on the case against him in SA.

"People still call Mr Dewani a monkey and ape months after (the statement), which only serves to denigrate him," Montgomery said.

Montgomery, who was submitting her closing arguments, told the court that extraditing Dewani in his current mental state would be "oppressive, harsh and unfair".

She said the fact that three psychiatrists had testified this week that Dewani was mentally unfit to plead to charges was "ground zero" for the basis for him not to be extradited.

In addition to suffering from sever depression and post-traumatic stress disorder (PTSD), Dewani was also at a high risk of suicide, the court heard.

"There is no clear prognosis for treatment. The evidence is all one way," Montgomery said.

"You are bound to pay attention to it," she added.

Montgomery said that even if he stayed in the UK, there was no realistic prospect of Dewani staying mentally fit.

She said the South African authorities should bring a fresh extradition application when he is better

Dewani is accused of being the mastermind behind the death of his wife of two weeks, Anni, who was murdered while on honeymoon in Cape Town last November.

Montgomery argued that sending Dewani to SA would be detrimental to his health.

"It is oppressive by our standards to extradite him. By each of the doctor's standards, he should be in hospital and not on trial," she said.

Turning briefly towards the Hindocha family seated to her left, Montgomery said: "It is in everyone's interest that there is a trial, but it must be a trial in which the man is (mentally) fit."

She admitted that there were cases where people were ill during their trial, and once it was over, they suddenly became better.

"But this is not the case with Mr Dewani. His symptoms of PTSD were caused by the events in South Africa.

"It is most unlikely that even if there was a trial and an acquittal, he will be relieved of the symptoms of PTSD. All the doctors agree that extradition will make him unfit," she said.

Montgomery took chief magistrate Howard Riddle through three case laws where precedents were set regarding fitness to stand trial, saying: "The law is clear that you cannot extradite people who are unfit."

Commenting on the facilities available to mentally ill prisoners, Montgomery said SA's prisons were incapable of providing the level of care that was needed to look after Dewani.

In addition to inadequate mental health facilities available, Montgomery said Dewani also faced being raped and possibly contracting Aids in prison if he is extradited.

In his closing arguments, the South African government's lawyer, Hugo Keith QC, said Cele had fully retracted his statement and that the commissioner was in no way directly involved in the case.

Keith added there would be no reason why Dewani would not get a fair trial in SA. He said SA's law regarding fitness to plead was similar to the UK's and the same fitness-to-plead tests would apply to Dewani in a South African court.

Keith was expected to continue with his closing arguments today.

Judgment in the hearing is expected to be handed down next month.

derstood by the poor.


"A house costing R16-million to construct only exists in the imaginations of rightwing, narrow-minded and obsessed white people, who always think Africans cannot and should not build houses of their

own," he said.

He later said he was referring to opposition parties Freedom Front Plus and the DA, which this week approached Sars to ask it to investigate the youth leader's lifestyle, and look into how he could afford a multimillion-rand home and luxury cars such as his Mercedes Benz C63, and if he were paying tax.

The accusations levelled against Hofmeyr have caused tensions in the NPA, with some members accusing their boss, Menzi Simelane, of

"hanging Hofmeyr out to dry".

"Mr King is interdicted from disclosing the content of the plea and sentence negotiations. It was agreed with his senior counsel, who conducted all the negotiations on his behalf, that all the negotiations between the parties would be held on a confidential and without prejudice basis," Mhaga said.


