ANC PRESS STATEMENT ON REPRESSION IN BOPHUTATSWANA.

A delegation of the ANC, including three members of the NEC, met

today with the ANC Bophutatswana Consultative Forum to discuss

the allegations made in the press by Dr. Lucas Mangope. The following facts emerged from the meeting.

The Bophutataswana police have consistently broken-up ANC branch meetings. The police broke up branch meetings in Thaba Nehu on the 1st and the 28th of October. Similiarly, meetings were disturbed

in Garankua on the 21st and 26th October.

Moreover, the Bophutatswana administration consistently refuses to respond to applications made by ANC branches to hold meetings. The Mafikeng branch sent three applications to hold a meeting on the 20th October- they are still waiting for a response. This has been the experience of other branches as well. The Mafikeng branch has submitted a futher application to hold a meeting on the 17th November. Up to this time, there has been no response from the Bophutatswana authorities.

On Saturday, 10th October, a busload of people, returning from an ANC meeting in Botshabelo, was attacked by Bophutatswana police. Many of the occupants of the bus were seriously hurl.

These facts demontsrate that Dr. Mangope's claim that democracy exists in the bantustan is untrue.

It is surely no coincidence that Dr. Mangope's absurd claim that there is an ANC "plot" to assasinate him comes on the day when thousands of people have stayed away from work in response to a call made by COSATU, the UDF and the Anti- Bophutatswana Co-Ordinating Committee. The stayaway was called to demand trade union rights in the bantustan.

It is clear that Mangope wishes to suppress every visible challenge to his illegitimate regime. He has used the nonsense of an ANC "plot" to further harass the democratic movement.

The ANC demands the immediate and unconditional release of all those who have been arrested and an end to the repression of the democratic movement in that part of our country.
