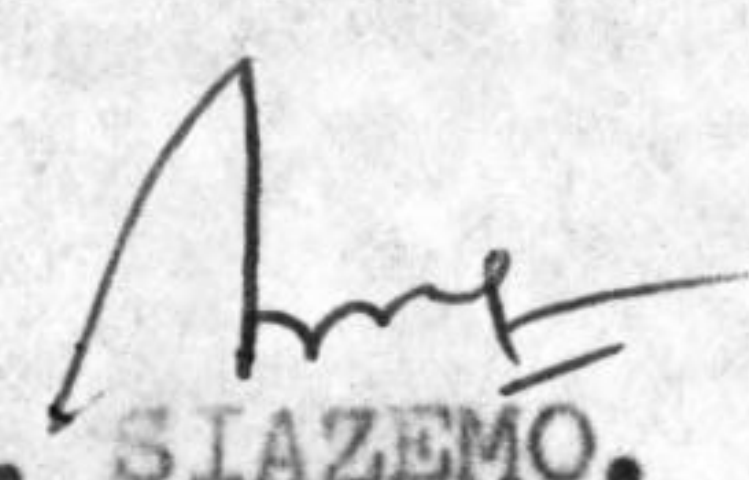
DEATH REPORT - AMPI NO. LUSR/109/92

Reference is hereby made to the above subject in regard to the death of Prohibited Immigrant.

The Late was taken to Hospital on 3rd July, 1992 at about 1645 hrs were he was admitted and died at 1719hrs. He died of upper respiratory obstruction.

The deceased was admitted into this Prison from Livingstone on 23rd June, 1992, he comes from South Africa. He has no relatives here in Zambia, that made this Office to contact the A.N.C. Officials to help us in allocating his relatives in South Africa, although this man was not an A.N.C. member. The A.N.C. Officials agreed to contact the Social Welfare Department in South Africa to help in this issue.
