MINUTES OF INSPECTION

PROJECT Moses Kotane Self-Reliance Centre, Viana, Angola

DATE 21st July 1987

PURPOSE OF INSPECTION

To inspect the delivery and erection of two Semi-detached Houses, two Dormitories, a Classroom and a Abulution block of Viana Construction Project, Phase two.

To draft a Certificate of Completion of Erection of mentioned buildings for Makrotalo.

INSPECTION

All buildings were inspected by studing their present condition. Markku Vesikko explained problems met during the work and measures taken to solve them.

A list of observations were compiled with evaluation and proposed actions (see below).

Makrotalo and Finnsolidarity were remarked on different items for correction or other measures to be taken.

EVALUATION

Quality of work carried out is better than in the first phase. This is obviously because of experience gained and improved material and technical solutions. There has been an exchange of manpower in construction and an occational lack of it. Part of the work hasn't been properly implimented and this has mostly been in the finishing works. Hence there is still some work and finishing off work which can be done in a short period of time.

The missing material will impede ANC from using a complete Dormitory block and part of the other, this material consists of louvre window glasses and mosquito or gauze wire. The Abulution block too can't be fully utilized because of some missing sewerage pipes for the hand washing basins. But as soon as all above mentioned materials have been received, fitting them and having the buildings fully operational won't

take much time.

Shortages of materials were replaced by Makrotalo during erection. Some faults in delivery were repaired or replaced by other materials which were agreed between Fisol and Makrotalo. These changes are acceptable and Makrotalo no longer has any responsibility concerning them.

The main fault of delivery is the painting of external wall element which is hatching. Presently 97 elements have been affected but it is expected that more elements will be damaged. Therefore Makrotalo is to study the matter and take the necessary action to correct this fault.

In conclusion, the delivery and construction is acceptable and the buildings are serviceable.

REMARK TO MAKROTALO

Makrotalo was notified on following:

- 1. Painting of 97 wall elements hatching. Makrotalo will study the cause of fault and take nessesary measures to replace or cover the fault by sending needed material.
- 2. Fixing screws of overflow pipe of hand washing basins are the wrong size 4mm, 5mm screws will be immediately delivered. Temporary fixing is done by using aluminium screws which might affect the basins.
- 3. Burglar bars oxidising, rusting. Makrotalo was given one bar for studuing the fault. Nessesary measures will be taken by Makrotalo to replace the material or sending needed material to cover the fault.

REMARK TO FINNSOLIDARITY

Finnsolidarity was notified on following:

- 1. Proposed actions to complete, correct or re-execute marked missings or faults in work where agreed and Fisol supervisors will instruct execution of them.
- 2. Missing materials according to inspection will be delivered by Fisol immediately.
