Goverment last September, we are in a proccess of working on the
arrangements for the return home of our peoale currently living
in Mozambique.

However, as we intend retaining our Mission in Maputo, after the
process is completed, we would be most grateful if the party and
Goverment could kindly allow us to continue occupying the houses
allocated to us by the Goverment, until the programme of repar-
triation is completed, when we shall be in a position to advice
the Party and the Goverment on the size of our Mission and hand
over to the authorities all the houses that we would no longer
need of. '
