- Meeting expresses concern that jup to now the Constitution Committee has not been furnished with Pojitical Guidelines as promised by the NEC in their letter of the 7tl/ February, 1986.

It is reported that Cde Pallo Jordan, NEC member, was instructed to draft the Guidelines by the NEC sub-committee on Constitution.

Now Cde Pallo Jordan in on a political mission in the USA and is rumoured to have lately joined ANC delegation in China.

Cde Jack reports to Cdes who were not present in our meeting of the 4th March that a decision was taken to circulate our first report to the NEC to the chairman - SACP and Secretary General - SACTU, inviting them to comment on the report and submit their suggestions to us before the 2nd April.

- None of the two officials have replied as yet.
- Meeting is asked to ratify thig decision of the 4th March Fo objection, ratified as requested.

The question is asked as to what the nature of our 2nd report shall be. - It is moved that we demand a meeting with the NWC on the 8th March,

1986 at $8.00 \, \text{a.m.}$ Thereafter we will be in a position to answer the question.

- Cde Pallo Jordan was to have drafted the Political Guidelines which have been discussed and decided upon by the NEC sub-committee.

Cde Ruth proposes meeting members of the Constitution Committee

to take down notes as she is being addressed by members of the

Committee.

She will reserve questions on matters she cannot provide satisfactory reply for the consideration of the NEC.

Apologises that the Political Guidelines are not yet available. Cde Albie should address her first as he is leaving.

The other members of the Committee will address them tomorrow at $9.00\ hrs.$

Cde Albie addresses the meeting on "what kind of a constitutional document does the NEC want".

He states that at the present stage the Committee should not attempt to draft & constitution.

Discusses briefly three constitutional formats, viz.:

Further proposes that at this stage ANC can produce set of papers analysing and exposing ANC policy; converting strategy and tactics into constitutional language.

The various ways of nominating the President were discussed, e.g. Nomination by Pclitical Parties, Electoral Colleges, Provinces, etc.

Foundation has established their headquarters at Carlton Centre, Johannesburg.

Have met personalities in the Transvaal and the Cape.

They are confidential (they claim) about their work.

They refused to present ANC with information about the stand of other people they met.

(e) Cde Zola further informs the meeting that he heard from Comrade Makhathink of our International Dept. that the group had approached the Australian government and had made a statement that ANC had given them greenlight for the continuation of their work.

The meeting commissions Cde Kader to write a memorandum on the work of the Foundation; the memorandum to be forwarded as an opinion to the NEC.

Discussion of Paper by David Chapman on "Electoral System for South Africa".

- Cde Kader introduces the topic and makes the following observations:
- (a) The Institute for Social Inventions is a relatively new organisation.
- It is not known in London. Its chairman is Nicholas Albery.

The Institute has commissioned David Chapman one of its directors to write a paper on "Electoral Systems for South Africa".

David Chapman is not a regular contributor to the $\operatorname{Guardian}$.

Word apartheid does not appear in the Document. Race is a referral point in the document.

It would seem the objection is not against Black government but radical government.

4. Meeting discusses the paper at length and instructs its Secretary to communicate its views to the NEC together with the memo prepared by Cde Kader.
