I did my higher education at Mountview Secondary. I completed the following subjects in my final year (1979)

- 1. Biblical Studies
- 2. Business Economics
- 3. History
- 4. Biology
- 5. Afrikaans
- 6. English

In 1980 I worked as a Youth Organiser for Y.C.S. (Young Christian Students). I was responsible for the Athlone (Cape Town) high schools area.

During the same year I started working as research and departmental assistant at the Faculty of Law, University of Cape Town. I was responsible for collecting data on pass law trials in the magistrate districts of Cape Town and assisting other sociological research workers at the University of Cape Town. During the period 1980 to 1984 we produced various publications.

In 1981 I co-authored a book on criminological statistics with Professor Dirk van Zyl Smit During 1982 I did a second updated edition on the same subject with Mana Slabbert.

In 1982 I part-time tutored at SACHED college in Foundation Sociology using my experience as a researcher.

I have acted as a tour guide to white high school students visiting and talking to the local residents of Crossroads, Khayelitsha, KTC, Hanover Park etc.

I have also gained experience as a freelance photographer/journalist. Some of my work appeared regularly in Frontline Magazine. On other occassions I acted as an assistant to Alistair Sparks and other visiting journalists.

During the same period I worked for UPITN (United Press International Television Networks) producing a 30 minute documentary on the effects of the Group Areas Act with their local representative (Clifford Bestall). This film was screened as part of their Roving Report Series and voted the best documentary in five years.

During my period at the University of Cape Town I enrolled for a BA.LLB course taking subjects such as Latin Intensive, Afrikaans (and part of African Economic History course). During my second year at the above institution I had to interrupt my studies after police harrassment and I then subsequently left the country In 1986/87 I worked as a Journalist and proofreader/translator for the ANC and MPLA respectively in Luanda, Angola.

During 1987 I attended the University of Oslo Summer school and attended courses in Development Studies and International Relations. In 1988 I was seconded to Lusaka and started working in the Department of Information and Publicity. At present I am working as a computer operator. My task is to produce camera-ready work for our printing department using the Macintosh micro-computer.
