I am MINNIE A. MITCHELL and I was born in Woodstock, Cape Province, South Africa. I lost my father at a very young age and to me he was only a picture on the wall. My mother was a hard working woman with very scant formal education. She had to support us (two children) by working as a domestic servant for white families. She however had a dream to give her children the best education she could afford so that we would not have to endure the same humiliation she did. I became a Primary School Teacher through much sacrifice on the part of the whole family. Mother always used to say education is something they cannot rob you of.

We belonged to the African Methodist Episcopal Church and I was glad that the church motto was God our Father, Christ our Redeemer and Man our Brother. I fully and truly adopted this motto. As a member of my church I became active in the Young People's Department and held office as District President also Secretary for many years. I was also active in the Women's Missionary Society and as a delegate took me to places all over South Africa, Namibia and once to Florida, USA. As a young teacher I became a member of the Teacher's League of South Africa up to the time it was banned. I was very active in the local chapter. Learned to know people such as Edgar Maurice, Easter Gordon, Benny Kies.

I was involved with organized sport through Primary School, College and in the private sector. Held office as treasurer and secretary and President of the Coloured Women's Hockey League in the Cape Province and one term of President in the Coloured South African Women's Hockey Board.

Though all these years I have been a strong supporter in the opposition of Apartheid and though I have not been a member of any political body as such, I have demonstrated in financial support without question. My way of fighting apartheid was influencing my school children that they were second to none. This was also transferred to my cwn children. I felt that if each person played their significant part in our struggle against apartheid we would eventually overcome. I was proud of my church which taught me that Brotherhood was a beautiful word and better still, the will to live this in our daily lives.

The apartheid laws affected me as it did others too. The Group Areas Act forced me to sell my home shortly after my husband's death. My only son was issued an exit permit when he wanted to study abroad. The Coloured Affairs Department was a thorn in my flesh. I saw many of my friends turning traitors towards their own people and thus I, through principle had to ignore those people. When I was forced to leave my home, I decided it was time for me to leave South Africa. I chose Canada as my new home. I am happy to state that here I renewed friendships with people such as Hazel and Dennis September and that my son married their daughter. This again brought me much closer to the Freedom movement. I collected funds in the office where I worked and also influenced the workers and friends to boycott South African goods, distributed information on the South African situation. I have also pledged regular financial contributions to the movement. It is now my wish to be counted as a member of the African National Congress (South Africa) and hereby apply for your approval.
