The Natal Church Leaders Group - a mission statement.

The Natal Church Leaders Group is an informal and autonomous association of the recogni sed

leaders of the following churches operating in the province of Natal:

Church of the Province of Southem Africa Methodist Church of Southem Africa

Evangelical Lutheran Church in Southem Africa Presbyterian Church of Africa

Roman Catholic Church

United Congregational Church of Southern Africa

It is hoped that the ecumenical base of the group will broaden to include other churches in the region.

The NCLG was formed on 7 May 1988 in response to the crisis in the Province arising out of the

political violence that by the end of 1990 had taken over 4000 lives, destroyed immense amounts

of property and turned thousands of families into rfugecs.

The Group meets on a regular (usually monthly) basis and its membership comprises the ${\tt l}$ eaders

of the above mentioned churches. In addition the NCLG is able to call on a number of ad visors,

facilitators and consultants to assist in its deliberations and work. Included among the ese are

resentatives of the regional Councils of Churches in Natal, the Vuleka Trust, Diakonia, PACSA, the South African Council of Churches, and Standing for the Truth Campaign. Any decisions made are by consensus and in no way innbit the leadership of the particular c hurches

from acting individually as they see fit.

The NCLG sees its mission as being a body through which the Church leaders can act deci sively

in crisis situations, through informing themselves of the issues underlying the crisis, supporting

each other in collective or denominational action, and through collective attempts at m ediation,

peacemaking, crisis relief, solidarity with the victims of violence, and prophetic chul lenge.

Among the variety of interventions open to the NCLG art the following:

- + Offers to mediate and facilitate peace talks between warring parties.
- * Negotiating with the state and challenging it to take appropriate uction to help reso lve the conflict and its causes.
- * Informing clergy and laypeople of the issues that underlie the violence so that more informed

decision making may be made by Christians at every level of involvement.

- * Training in conflict handling.
- * Supporting each other in crisis situations.
- * Supporting appropriate interventions by other bodies aimed at addressing the crisis.

- * Acting through immediate responses, pastoral visits and crisis relief (usually through the Natal Crisis Fund) to bring care and hope to the victims of violence.
- \star Planning for reconstruction when the violence ends.
