Please plan to testify against the proposed repeal bill (LD 2215)
and bring as many friends as possible to the above hearing!

- The South African Ambassador, Harry H. Schwartz, has has traveled to Portland and Augusta recently to lobby for this repeal.
- Archbishop Tutu, the Mandelas, and the black South African majority continue to call for our support to uphold divestment. White South Africans increasingly join this call.
- Despite South Africa's claim of progress, no black South African can vote.
- In 1991 alone, divestment earned \$484 million for Maine's retired state employees. Divestment Works!!
