Dear Comrades,

After consultation with Cde Maduna of our Legal department, we requested passport application forms for ANC members who need to travel to South Africa. The completion of these forms is not obligatory, however the Office advises comrades to do so as this will considerably facilitate matters should the need occur to travel to SA. It must be pointed out that the issuance of the passport does not imply indemnification, which is a separate matter and handled through ANC channels.

Enclosed are two forms, both to be completed:

- 1. Passport application(yellow form)
- Identification form(white). As we do not have any South African identification this information is required.

Also enclosed are specimen forms to show you how to fill in the forms. Please follow carefully and use block letters throughout when supplying information.

Return both forms to this Office together with two passport pictures.

HQ instructs that comrades should not pursue these matters on the own with South African Embassies/Legations. All dealings in this regard should be dealt with through the relevant ANC Mission. Missions are allowed to make contact with the Ebassies/Legations only for purposes of facilitating travel to South Africa.

I will be departing for South Africa on the 26th of June and suggest that should you wish to complete the forms, these be returned to me before the 25th for transmission to the SA Legation here in Helsinki.

I will be back on the 15th of July.


