7. The OpemtiOns Group should have a representative from each regional JWC. The National Alliance Fo.m should meet monthly. Operations Group stems from the NPA and has a team from regiona. tailiance structures. Cdes who sit on national sub-ccmrnittees aim participate in it.

8. On the issue of the participation of Chiefs in the structures of the National Peace Accord, it was resotved that we need to take up this issue in all relevant structures to force their panicipmion. while maintaining regional flexibility.

9. On the issue of international campaigning around the violence. the workshop recommended that we need to maintain and upgrade tinkz with our allies abroad on the issue.

6. We must campaign to few: the. regime to disclose crimes committed by the security forces once and for am. This should no: be taken up immediately. but at a later stage. We need to link this with our monitoring.

Once minutes and summary recommendations are out. reporting back and discussions at JWC level need to start. Where there: are no IWC: these need 20 be set up quickly. The setting up of MC; must be discussed in constitutional smctures first. Full time staff on violence must be brought into discussions of the Operations Group. Alliance leadership must discuss this report at a special meeting and ascertain what our people are saying about violence.
