The two organisations also discussed issues around economic policy. They expressed themselves in favour of a package of economic policies which will address the current imbalances in economic power, income and wealth distribution. In this regard, they agreed that co-operation between the two organisations should be strengthened in order that policies which eventually emerge for a post-apartheid South Africa are broadly representative.

The two organisations agreed that regular meetings and consultations will become a feature of the coming period and thus instructed their relevant structures to carry this out.
