## TERMINATION OF STAFF CONTRACTS

Following a decision taken by the NEC about the winding up of our Projects at Mazimbu and Dakawa by the middle of 1992 and taking into account that the bulk of our population will be repatriated by the end of January 1992, the Task Force proposal that all contarcted staff be given notice with immediate effect has been endorsed by the NWC. On the basis of this decision, an Inter-Departmental Delegation has been sent to Tanzania to effect the winding up process.

We hereby, therefore, officially give notification that all those who are contracted to work at Mazimbu and Dakawa for a period of one year, should consider that their contracts are being rescinded.

Kindly inform all concerned that the working/employment contracts entered into with the ANC are deemed ineffective as from 31st December 1991.

We sincerely regret any inconvenience caused but are confident that the comrades concerned will appreciate the special circumstances pertaining at present.

## ANC SETTLEMENTS MAZIMBU AND DAKAWA

As we approach the commencement of the negotiation process for a new political dispensation for South Africa, the African National Congress reaffirms its strong ties of frienship and solidarity with Chama Cha Mapinduzi and the people of Tanzania.

During the years of exile, we have been the recipients of considerable and generous assistance from the Party and Government of the United Republic of Tanzania. We are indeed very proud that the first headquarters in exile of the ANC was located in Morogoro. Many of our heroes and heroines lie buried in your hospitable soil.

After the SOWETO Uprising which led to the exodus of thousands of ANC cadres, Tanzania opened its doors to provide sanctuary and hospitality to thousands more victims of racist oppression.

Today, two huge Settlements at Mazimbu and Dakawa are testimony of the solidarity and friendship between the Party and people of Tanzania and the oppressed people of South Africa.

The time has come when we are making preparations to repatriate all our cadres to South Africa where the struggle will continue to bring into being a new, democratic, nonracial and non-sexist society.

Already, nearly a thousand people have returned to South Africa and most of the remainder will come back by early 1992 with the assistance of the UNHCR.

The National Executive Committee has decided to bring to a close our activities at Mazimbu and Dakawa during the first half of 1992 and to formally handover the two Settlements to CCM in the latter half of 1992, barring unexpected negative developments.

An NEC-Commissioned Delegation has been sent to Tanzania with the mandate, in collaboration with our Chief Representative accreditted to Tanzania, to make the necessary recommendations and plans for the winding up of our activities and the handover of the Settlements to CCM.

The ANC will greatly appreciate the advice and contribution of CCM and the Government in the historic exercise of the transfer of the Settlements of Mazimbu and Dakawa from the ANC to CCM.

We reiterate affirmation of the indissoluble bonds of friendship and solidarity between our fraternal organisations and people.
