The Ministry of Foreign Affairs of the Republic of Italy and all Diplomatic Missions and International Organisations accredited to the Quirinale. STATEMENT BY HON. VERNON J. MWAANGA, MP., MINISTER OF FOREIGN AFFAIRS, ON THE ESCALATING VIOLENCE IN SOUTH AFRICA - THURSDAY, 10TH DECEMBER, 1992

The Government of Zambia is gravely alarmed about the escalation of violence in South Africa which has led to senseless injury and loss of life.

Zambia is committed to dialogue and national reconciliation in South Africa and believes that there must be strict adherence by all the Parties to the National Peace Accord of September, 1991.

Actions and statements by APLA (Azania People's Liberation Army), the Military Wing of the P.A.C., accepting responsibility for the recent attacks on civilians in King Williams Town and Queenstown are unacceptable and seriously jeopardise the peace process in South Africa which we all genuinely desire. It is a matter of utmost regret that innocent people who are trying to live normal lives are always the victims of disciples of Violence.

We remain faithful to the Lusaka manifesto of 1969, on Southern Africa which was subsequently unanimously adopted by both the O.A.U. and the United Nations General Assembly, which states that "... we prefer to negotiate rather than fight...". We wish to make an earnest appeal to all our brothers and sisters in South Africa to put an end to violent confrontation and embrace dialogue. We are disturbed that factional Violence has claimed nearly 9,000 lives since 1990. We are doing our utmost to help bring about a new non-racial, nonsexist and democractic South Africa. However, this new South Africa cannot and will not be born from a political womb which is so pregnant with Violence, mistrust and despair. We urge the Government of South Africa, the ANC, the PAC and other key political players to speed up the constitutional process in order to ensure that a Government of National Unity is established in South Africa during 1993. In this regard, we appeal to our brothers and sisters in the Inkhata Freedom Party (I.F.P.) led by Chief Mangosuthu Buthelezi to rejoin the peace process and abandon its alliance with white extremist elements who are enemies of democracy and who are hell-bent on disrupting the whole constitutional process which appears to be gaining momentum.
