BRIEF HISTORY OF THE FORMATION OF THE SOUTH AFRICAN CRICKET BOARD (SACB)

At its Third Council meeting on the 10 November 1976, the Natal Cricket Board of Control, unanimously accepted to implement the directive of the South African Cricket Board of Control (SACBOC) to play \(\frac{a}{200}\)234normal\(\frac{a}{200}\)235 cricket in Natal. The Natal Cricket Board of Control decided to implement the directive only if \(\frac{a}{200}\)234normal\(\frac{a}{200}\)235 cricket in Natal was to be played according to the 12 point plan (which was accepted by its counter paw that it had drawn up. At this point in time all units of SACBOC, except the Western Province Cricket Board (WPCB) and NCB, had decided to play normal cricket,

However, this set up only lasted two months as the NCB rejoined the WPCB outside the folds of $a\200\234$ nor-mal $a\200\235$ cricket at its 5th Council Meeting when it resolved by a substantial majority to withdraw from $a\200\234$ normal $a\200\235$ cricket in Natal because the $a\200\234$ agreement to play $a\200\235$ was not adhered to.

At the same meeting the NCB and WPCB decided to play a friendly inter-provincial at Tills Crescent in March 1977. It was during this match that cricket officials of NCB & WPCB with interested members of other non racial codes and SACOS officials met in the Tills Crescent dressing room to discuss the state of non racial cricket. The meeting unanimously agreed that the â\200\234normalâ\200\235 cricket scene was a farce and that the betrayal of the non-racjal cause by the leadership of SACBOC in its capitulation to racial cricket, and their inability to call a meeting to give satisfactory explanations to the rank and file members of the organisation should give rise to the birth of a new non racial cricket body.

Thereafter a Cricket Summit Meeting was held in

Kimberley on the 25 September 1977 which was attended by officials of WPCB, NCB, E.P. Cricket Association (EPCA) the newly formed Transvaal Cricket Board (TCB) and Griqualand Cricket Union. Messages of support were received from South Western Districts Cricket Union. South African Senior Schools Sports Association (SASSSA) and South African Primary Schools Sports Association (SAPSA). The meeting was chaired by Mr H. Rose of Kimberley. From the attendance and discussion it was clear begond any doubt:-

- (a) that the overwhelming majority of pavers and officials of SACBOC were totally opposed to the policies and actions of SACBOCâ\200\231S officials;
- (b) that for reasons best known to him the SACBOC President was determined to carry on with the $\frac{3}{200}^230\hat{2}00$ started by him;
- (c) that he would make every effort to frustrate efforts to bring SACBOC back to the non-racial stand

which made it one of the leaders in the struggle against racialism in sports.

he meeting unanimously agreed to form the South African Non-Racial Cricket Committee to investi-

ate reforming or recapturing SACBOC.

n the meantime, according to reports in the Afrikaans press, of the 3 SACBOC representatives on the 9-man motivating Committee only the late Rashid Varochia was present at the meeting at which the South African Cricket Union was formed. Messrs Pat Naidoo and Les Petersen, the, other 2 representatives, did not attend the meeting, but to give it credibility, other Officials of SACBOC and the Transvaal Cricket Federation were present at the meeting.

The inaugural meeting of the SACB was held at the AEL Centre in Johannesburg on the 13 November

1977, where it was unanimously decided that a new non-racial cricket body should be formed called the South African Cricket Board (SACB). Present at the meeting were delegates from WPCB, EPCA, TCB, NCB, SwDCB & GWCU. The NCB draft constittion was read, amended and accepted unanimously.

SASSA & SAPSSA were a full membership to SACB. The officials elected were:-

President: H. Howa

Vice President: Sheik M.G. Booley

Secretary: A.W. Kazi

Treasurer: B. Leendertz Record Clerk: L. Smith

It was also unanimously decided to immediately forward a formal letter of application for membershi to the South African Council of Sport (SACOS). It was due to this application that SACBOC, the existing member of SACOS, was given 90 days to put its house in order.

The acceptance of the SACB at the SACOS Biennial meeting held in Cape Town on 6 March 1978 once again gave non racial cricket its rightful place among

ational Non-Racial Sports Organisations. The SACB pledged its unreserved acceptance of and support for the principles and aspirations of SACOS and has expressed its total solidarity with other national bodies in the struggle for non racial sport in South Africa.

In its memorandum to the International Cricket Conference in 1978 the SACB stated that whatever optimism that existed after the discussions of 18 January 1976 between the representatives of the various National cricket bodies and the Minister of Sport, was finally shattered with the announcement in September 1976 of the Governments new sports policy: It became abundantly clear that the â\200\234New ealâ\200\235 would be nothing but the extension of the multinational policy to club level. The State also

clarified its policy in so far as schoolâ\200\231s sports was concerned: a series of approvals from several different authorities were necessary before schools could come against one another on a multinational asis.

Clear $\hat{a}200\234$ Demands of non-racial sport $\hat{a}200\235$ was also laid down in a June 1979 SACB memorandum.

They were:

- (a) All clubs must have open membership. Where exclusion clauses are incorporated in club constitutions, they must be removed.
- (b) All clubs must participate in competitions organised by single non-racial controlling bodies at local, regional or provincial level.
- (c) A single non-racial body must control the sport nationally and represent the sport internationally.
- (d) All sportsmen and sportswomen must have equal opportunities in private and public life.
- (e) Sponsorship must be utilized in such a way that all sportspersons benefit equally.
- (f) There must be no restrictions placed on clubs or other sports organisations in the acquisition of private sportsgrounds and club facilities, and all such facilities must be open.
- (g) Sports facilities must be provided to all sportppetaene without discrimination and on an equal asis.
- (h) Selection must be based solely on merit in the composition of representative teams.
- (i) South Africa must be represented internationally by a single team selected on merit.
- (j) All school children must be free to attend the schools of their choice and school sports must be free from any restrictions based on race or other abnormal considerations.

The subsequent successful development of the $\frac{3}{200}$ as a force in South African Sport and its rec-

ognition by International Cricket bodies is quite well ${\tt known.}$

The main thrust of my message is the player $200\231$ s role and responsibility in the non-racial

sports struggle. It is foolhardy to ignore the belief that every player within the fold s of the

S.A.C.B. has a role to play in the struggle for non-racial; sport in this country. Onec annot

ignore the fact that the struggle for freedom in sport is intrinsically linked with the struggle

for freedom of the oppressed people in this country.

Basically, the role of the non-racial sportsperson is for him to identify himself with the aims

and objectives of the South African Council of Sport. The non-racial sportsperson has a responsibility to himself, to the sport and to the national organising body. He has a responsibility to sell the concept of non-racialism to others, convince others to be dedicated, loyal and committed, and persuade the errant to return to the folds of non-racialism.

The S.A.C.B. is growing in strength despite the lack of major sponsorship, TV and news coverage simply because it identifies with the aspirations of the majority of the count $ry\hat{a}\200\231s$ population.

am amazed and flabbergasted at the multi-national companies and business corporations who are continuing to deny non-racial cricket a helping hand. This is even more galling when one considers that both our Under 21 and Under 16 S.A.C.B. Tournaments hace no sponsorships wharsoever. Our parent body , S:A.C.B., therefore, has to draw on its own resources to promote and nurture junior cricket.

To our detractors, let me spell it out loud and clear, that there is nothing sinister in being

non-racial. However, the reverse is true where racial sport for the exclusive benefit o f one

racial group is wrong and demeaning. | want to appeal to all the corporate giants and major companies - cut out the gimmicks and publicity bashing and get involved where it really counts.

To all the players | must stress a singular fact - much has been achieved in this count ry

because of the standpoint of non-racial sportsmen, and whatever change or legislation i ${\sf s}$

due primarily to their committment and dedication. Let us not be impressed by a prejudiced and jaundiced media which purports to convey the truth. Let us not yield to the

forces of coercion. Wear your colours with dignity and be proud of it.

as adopted at the Congress of the People on 26 June 1955.

Preamble

We, the people of South Africa, declare for all our country and the world to know: That South Africa belongs to all who live In it, black and white; and that no government can justly claim authority unless It Is based on the will of the people;

That our people have been robbed of their .birthright to land, liberty and peace by a form of government founded on injustice and Inequality;

That our country will never be prosperous and free until all our people live in brotherhood, enjoying equal rights and opportunities;

That only a democratic state, based on the will of the people, can secure to all their birthright without distinction of colour, race, sex or belief;

And therefore, we the people of South Africa, black and white together - equals, countrymen and brothers - adopt this FREEDOM CHARTER.

And we pledge ourselves to strive together, sparing nothing of our strength and courage, until the democratic changes set out here have been won.

THE PEOPLE SHALL GOVERN!

Every man and woman shall have the nght to vote for, and stand as a candidate, for all bodies waich make the laws.

All the people shall be entitled to take part in the administration of the country.

The right of all the people shall be the same, regardless of race, colour or sex.

All bodies of minority rule, advisory boards, councils and authorities shall be replaced by democratic organs of self-government

â\200\230ALL NATIONAL GROUPS SHALL HAVE EOUAL RIGHTS!

There shall be equal status in the bodies of state, in the courts and in the schools, for all national groups and races.

All national groups shall be protected by law againsy insults to their race and national pride.

All people shall have equal nights to use their own languages and to develop their own folk culture and

customs.

The preaching and practice of national, race or colour discrimination and contempt shall be a punishable

crime.

All aparheid laws and practices shall be set aside.

THE PEOPLE SHALL SHARE IN THE WEALTH OF THE COUNTRY!

The national wealth of our country, the heritage of all South Africans, shall be restored to the people. The mineral wealth beneath the soil, the banks and monopoly industry, shall be transferred to the

ownership of the people as a whole.

All other industnes and trade shall be controlled to ensure the well-being of the people.

All people shall have equal rights to trade where they choose, to manufacture and to enter all trades, crafts and professions.

THE LAND SHALL BE SHARED AMONG THOSE WHO WORK IT!

Restriction of land ownership on a racial basis shall be ended, and all the land re-divided amongst those who work it, to banish famine and land hunger.

The state shall help the peasants with implements, seed, tractors and dams to save the soil and assist the ullers.

Freedom of movement shall be guaranteed to all who work the land.

All shall have the right to occupy land wherever they choose.

People shall not be robbed of their cattle and forced labour and farm prisons shall be abolished.

ALL SHALL BE EQUAL BEFORE THE LAW!

No one shall be imprisoned, deported or et without fair trial.

No one shall be condemned by the order of any government official.

The courts sta be representative of all the people. Imprisonment shall be only for serious crimes against the people, and shall aim at re-education, not vengeance.

The police force and army shall be open to all on an equal basis and shall be the helpers and protectors of the people.

All laws which discriminate on the grounds of race, colour or belief shall be repealed.

ALL SHALL ENJOY HUMAN RIGHTS!

The law shall guarantee to all their right to speak, to organise, to meet together, to publish, to preach, to worship and to educate their children.

The privacy of the house from police raids shall be protected by law.

All shall be free to travel without restriction from countryside to town, from province to province, and $a\200\230$ from South Africa abroad.

Pass laws, permits and other laws restricting these freedoms shall be abolished.

THERE SHALL BE WORK AND SECURITY!

All who work shall be free to form trade unions, to elect their officers and to make wage agreements with their employers.

The state shall recognise the nght and duty of all to work, and to draw full unemployment benefits.

Men and women of all races shall receive equal pay for equal work.

There shall be a forty-hour working week, a national minimum wage, paid annual leave, sick leave for all workers, and matemity leave on full pay for all working mothers.

Miners, domestic workers, farm workers and civil

servants shall have the same rghts as all others who work.

Child labour, compound labour, the tot system and contract labour shall be abolished.

THE DOORS OF LEARNING AND CULTURE SHALL BE OPENED!

The government shall discover, develop and encourage national talent for the enhancement of our cultural life.

All the cultural treasures of mankind shall be open to all, by free exchange of books, ideas and contact with other lands.

The aim of education shall be to teach the youth to love their people and their culuire, to honour human brotherhood, liberty and peace.

Education shall be free, compulsory, universal and equal for all children.

Higher education and technical training shall be opened to all by means of state allowances and scholarships awarded on the basis of ment.

Adult literacy shall be ended by a mass state education plan.

Teachers shall have all the rights of other citizens. The colour bar in cultural life, in sport and education shall be abolished.

THERE SHALL BE HOUSES, SECURITY AND COMFORT!

All people shall have the right to live where they choose, to be decently housed, and to bring up their families in comfort and security.

Unused housing space shall be made available to the people.

Rent and prices shall be lowered, food plenuful and no one shall go hungry.

A preventative health scheme shall be run by the state.

Free medical care and hospitalisation shall be provided for all, with special care for mothers and young children.

Slums shall be demolished and new suburbs built where all have transport, roads, lighting, playing fields, creches and social centres.

The aged, the orphans, the disabled and the sick shall be cared for by the state.

Rest, leisure and recreation shall be the night of all. Fenced locations and ghettoes shall be abolished and laws which break up families shall be repealed.

THERE SHALL BE PEACE AND FRIENDSHIP! :

South Africa shall be a fully independent state which respects the nghts and sovereignty of all nations. South Africa shall strive to maintain world peace and the setuement of all intemational disputes by negotiation - not war.

Peace and fnendship amongst all our people shall be secured by upholding the equal nghts, opportunities and status of all.

The people of our neighbours Lesotho, Botswana and Swaziland - shall be free to decide their own future. The nght of all the peoples of Africa to independence and self-governm 7: shall be recognised, and shall be the basis of close co-operation.

Let all those who love their people and their country now say, as we say here:

THESE FREEDOMS WE WILL FIGHT FOR, SIDE BY SIDE, THROUGHOUT OUR LIVES UNTIL WE HAVE WON OUR LIBERTY

JUNIOR TOURNAMENT RULES

The CONTINGENT shall comprise of 14 players, 1 Manager, 1 Umpire who shall be of suitable standard.

All selected players shall be registed 14 days prior to participating in the tournament. The computation date shall be Under 21

Under 16

Proof of age to be submitted to scrutiny committee at the tournament in addition to registration 14 days prior to the tournament. Birth certificates or certified copies thereof. Time of arrival to be advised to host unit 7 days in advance.

HOURS OF PLAY: Play shall commence punctually at 9.30am each day and end at 6.30 or earlier if outright decision has been reached. There shall be a lunch interval of 45 minutes and a tea interval of 15 minutes. Drinks breaks may be taken midway between each session.

POINTS

Win by Innings or Default - 12 points

Win on double innings - 10 points

Tie on double innings - 5 points each

Tie on first innings - 2 points each (Incomplete innings) Win on first innings - 4 points (Incomplete match)

There shall be no bonus points.

OVER: The over shall consist of six balls.

A new 2pc or 4pc ball of 5.50z shall be used for each match.

A second new ball may be used at the commencement of the second innings. Teams must maintain an over rate of at least 16 overs to the hour.

A minimum of 20 overs shall be bowled in the last hour of play of each match. ${\tt TOURNAMENT}$ WINNERS

Shall be the team with the most points.

In the case of a tie, by the team with the most outright wins.

If there is still a tie, then by the team who scored the most runs per wicket.

All participating units shall pay their own Travel costs to the tournament. S.A.C.B. will provide Accommodation and meals at its cost.

Accommodation will be the responsibility of the host centre, and must be within the budgetery stipulations of S.A.C.B.

All matches shall be played on a league basis, under the normal ICC Rules, save for the rules set out above.

Where tournament is played in sections, the winners of each section shall play-off for tournament winners.

A briefing meeting shall be held before the tournament commences, as well as a debriefing meeting at the end of the tournament. A full report to be submitted to SACB, of any recommendations made at such meetings.

A SACB X1 vs INVITATION X1 to be selected at the end of the tournament, the match to be played on the last day $\,$

In the Under 21 Tournament, a selected Under 21 $\rm X1$ will play against a BOOLEY $\rm X1$ on the last two days of the tournament.
