- (b) A second tier which would be responsible, inter alia, for the storage, transportation, bulk treatment and delivery of purified water; and

 \hat{A} £ \hat{a} \200\230i (c) A third tier responsible for reticulation of water to individual consumer s.

There are, of course, variations on the above but it is our view in Umgeni that the whole country should be covered by second-tier institutions such as the current "water boards \hat{a} \200\235.

- o The object of writing this letter to you, however, is to convey a feeling which exists at a high
- ${\tt "}$ level in KwaZulu and indeed in certain other political circles in Natal. Bearing in mind the
- strong feeling in some quarters for forceful regional government the first-tier authority in the $\ensuremath{\text{n}}$

above modei need not necessarily be at Central Government level, but could be at regional government level. Thare would obviously, in such a case, have to be some umbrella-type body at national level, but with less powers and obligations than at the current first-tier situ ation.

that the negotiating process may forge ahead smoothly.
