The above mentioned is a toddler of 2 years attending at the creche. On the second week of September a Cde by the name of Given from Dakawgpamito took Taketeo on two occasions from the creche in the afternoon. Our aiser- in- laws who were on duty those days thought that Thembi is related to Given, because when Takatso saw him she immediately ran to him.

In the process of Takatso being taken an earring got lost, then the mother questioned the teachers about the earring, one of the teachers mentioned that it could have got lost when Takatso was taken by Given (all along we didn't know his name) Takatso's mother asked to meet the person in SOMAFCO office. When Thembi saw Given (who came to her drunk) she suggested that I have to be told and investigate the matter further.

On Monday 27th. 9 88. the matter was reported to me, and I asked the people who were on duty that did they see one child from the creche since it's a rule that no child is to be taken by unknown person under no circumstances.

On Tuesday 28th. 9. 88. I was called by Cde Tim Maseko who discussed the matter with me, at first I wondered in! how it came to him and not discussed with me, I later understood that Thembi told him on the grounds of being a mother. On the 30th 9.88. I received a letter from Thembi on the matter. I called a meeting with her and Given but Given didn't attend, only Thembi came. In the meeting we decided that we must include S.O.U

In the meeting with Thembi we tried to establish points asked in her letter but we didn't establish noB. and she mentioned to us that she took the child to the hospital where she was told that she has to look for certain symptoms or she has to be checked, but it was hkuvugakslto her that if she's checked it will have a heavy psychological impact on Takatso ( she had a fear that the child genitals might have been fiddled with).

WE had called a meeting with structures copied , S.O.U.. Given in the absence of the mother because of the feeling that can happen to children in Dakawa I Mazimbu not Takatso alone, the meeting was held on the 13th October 1988. at D.C.C. office but only chief administrator and the rep from the children's desk were present, where we took a decision that the matter be referred to the complex disciplinary committee.
