On tuesday 28th. 9. 88. 1 was called by Cde tim Maseko who discussed the matter with me, at first 1 wondered in! how it came to himand not discussed with me, 1 later understood that Thembi told him on the grounds of being e 1.ther.On the 30th 9.88.1 recieved a letter from Thembl on the m.tter. I called a meeting with her and Given but Given did'nt attend , only Thembi came. In the meeting we decided that we must include S.O.U

.1n the next meet and other eructureecepied ins In the meeting with Thembi we tried to establish points asked in her letter but we din'nt establishnoB. and she mentioned to us that she took the child to the heapital where she was toled that she has to look for certain symtoms or she has to be checked, but it was hkvuqakslto her that if she's checked it will have a heavy psychological impact on Takatso (she had a fear that the child genitals might have been fiddled with).

WE had called a meeting with sructurescopied , S.O.U.. Given 1n the absence or the mother because to the feeling that can happen to children in Dakawa I Mazimbu not Takatso a alone, the meeting was held on the 13th October1988. at D.C.C. office but only chief administrator and the rep from the children's desk were present, where we took a decision that the matter be reffered to the coplex disciplinary committee.
