We would also like to take this opportunity of reminding you of previous letters sent to MHQ requesting assistance with the identification and release of other cadres to work within our structures. (We enclose copies) We were specifically requesting someone to represent us in East Africa and for artists for our workshops, but further to that we have need for people to work in the sports area, including a co-ordinator of the Sports Desk and someone for our Research and Documentation Centre. This person would learn all the skills necessary to establish a data and documentation base, organise a library and do research, under the training of a CUSO co-operant who is with us for a year.
