As concerning the work we have been assigned to do by the office of the Chief Rep at the IKT Section of the Tanzanian People's Defence Force through the invitation of the NEC Secretary-Ministry of Propaganda and Mass Mobilization, we have managed to do the best that we could. As for myself as a person I have been greatly disturbed by the arrival of a very insolent Preston Selepe to whom I had to pay some attention including a lot of confusion that he has spread within the short space of time he has been here. This is to inform all concerned bodies in the region that whatever the reason of this Preston's presence in East Africa it has got nothing to do with the Department's Organizational and Administrative issues and this therefore serves as an official nullification of whatever deliberations and/or agreements he has entered into on behalf of this Department concerning such issues .

You are hereby also kindly advised that anybody masquerading in the region as an official concerning Regional Cultural Organizational and/or administrative matters without any credentials either from the DAC Headquarters and/or the Office of the DAC Representative in East Africa is an impertinent impostor and should be treated with due disregard or at the most reported to social order structues

The Department takes a very serious exception to this kind of suspicious conduct by Mr Selepe and is taking it up with Headquarters and other relevant structures
