A national consumer boycott was proposed for the week following the opening of parliament and there should be definite time limits given for this.

The convening of a Patriotic Front by the ANC to evolve common strategy against Apartheid, should take place before De Klerk convenes his Multi-party summit A week long stayaway was proposed to take place in June 1991. (This will only happen if the State has not responded to our demands and in consultation with our allies)

From February the ANC should embark on the following programme to speed up the dismantling of the Bantustans and educating our people on the demand for a Constituent Assembly:

- A signature campaign which will entail door to door work
- an ARC delegation to Bantustan leaders pressurise them into meeting the demands of the people at the local level and informing them of the ANC's programmes to dismantle Apartheid
- the calling of a referendum in those Bantustans where it is appropriate

The Commission felt strongly that the campaign on education should focus on the re-orientation of the community and students towards W-

The commission proposes the following theme for the Education â\200\235 Mass Education Now"

'The campaign could be divided into medium and short term objectives:

1. 2.

Medium Term: One education system for all.

Short Term:

For the past few years our movement has been calling for students to go back to school. Unfortunately this call did not take into consideration that there were many factors militating against effective learning.

The commission felt strongly that the ANC must be seen to be addressing the Education Crisis in the country. The Commission recommended that it be done in the following ways:

- a) The ARC should set in motion processes that will ensure that education is open to all our people, young and old. This will be done by branches initiating Adult Schools. The following guidelines should be used for this purpose:
- 1) Regions and branches should set up Task Forces which should indentify and then negotiate with Church and School authorities for premises to be used. Also unused white schools need to be identified.
- ii) Teachers should be asked to conduct classes. A special appeal should be made to university students, professionals and returnees with skills to assist.
- iii) We need to approach businesses for sponsorship towards the infrastructure and running of these schools.
- iv) Branches could consider charging a nominal fee to prospective students in order to help build self-reliance.
- ${
 m v})$ Branches should initiate mass action to pressurise provincial authorities to subsidise such schools and pay teachers salaries.
- b) It is proposed that as part of re-orientating the community towards the culture of learning the following sub-theme should be adopted - " Prepare for National Democracy -Learn New!"

This sub-theme should be manifested in the following way:

1. A call by the leadership for the students to go back to school and ensure that effective learning takes place. The emphasis of the speech should be on the reasons why students should return to school. This call should be made in the January 8 Speech.

- 2. Demand from the state the provision of resources such as stationery, text books etc. $\,$
- 3. The ANC must demand an increase in state expenditure for black education.
- 4. The ANC should pressurise the state before the opening of parliament to meet the above demands.
- 5. The ANC should explain fully to the NECC, COSAS, SANSCO, NUSAS the details of this campaign.
- 6. The ANC branches should set up Education Units which should inter alia monitor safety at schools, to fight against gangsterisn, sexual and drug abuse.
- 7. That the ANC actively support existing campaigns of the NEcc and other democratic organisations. An example being

the opening of all schools to all people.

A programme of action on the issue of violence has been addressed by the commission on Violence. ${\tt WFR}$

The commission strongly noted that the ANC's Policy on Affirmative Action for women had not been implemented. The commission recommended the following:

- a) that 8 March should be a day set aside to focus on womens issues nationally. A proposal for marches around violence against women to be held on this day.
- b) The ARC must implement its policy to adequately include women on all its structures. The present representation of women on structures is not proportional to the actual membership of women in the ANC.
- c) that branches should discuss the issue of gender and specifically look at the document on Gender and the Constitution and to actively get involved in the Womens' Charter Campaign
- (1) Branches should seriously address the problem of sexual harassment

A number of problems were raised with regards to the nature of our organisation and a resolution has been submitted to the resolutions committee. The Commission discussed:
