1. OPENING OF THE MEETING AND WELCOME

P Maduna opened the meeting at 10H15, Monday 4 May 1992.

2. APOLOGIES

There were no apologies as all delegations were present.

3. RATIFICATION OF THE MINUTES OF THE TENTH MEETING OF WORKING GROUP 3

3.1 Amendments were made to the following sections of the minutes and should now read as follows:

5. Submissions from The Women's Lobby and the Pinetown Child and Family Welfare Society were received by WG 3 and noted.

10.2.3 The matter was not pursued any further.

10.2.1 L Mtshizana raised the issue of CODESA participants undermining the CODESA process by holding discussions outside CODESA on the future of CODESA and then projecting CODESA publicly in a bad light. He wanted it to be noted that the Transkei delegation objects to this. The SACP supported the Transkei's objection.

3.2 P Hendrickse proposed, A Rajuili seconded and the Working Group duly accepted ratification of the minutes with the above amendments included.

3.3 P Maduna reported that the DMC had taken up the matter of the misrepresentation of the first Technical Committee Report by the SABC with them. An apology was made by SABC for misrepresentation and a promise made to correct the irregularity.

4. TABLING OF MINUTES OF WG3SC AND MATTERS ARISING

The minutes of WG3SC were tabled. There were no matters arising.

5. TABLING OF SUBMISSIONS

No submissions were tabled.

6. TABLING OF REVISED TECHNICAL COMMITTEE REPORT

- 6.1 P Maduna reported that the Technical Committee had met on Saturday, 2 May 1992.
- 6.2 At this meeting, outstanding matters from the previous meeting had been given attention. The Technical Committee hopes to revisit the issues once delegates have given feedback from their principals.

7. ADOPTION OF AGENDA

The agenda was adopted as proposed.

8. MATTERS ARISING FROM THE TECHNICAL COMMITTEE REPORT

- 8.1 All delegations gave feedback on the technical Committee Report as agreed in 6 above.
- 8.2 Discussion on these inputs followed.
- 8.3 The Technical Committee was asked to revise its document on the basis of the above mentioned feedback and discussions, for tabling to the Working Group.
- 8.4 The Technical Committee tabled a second report to Working Group 3 on Tuesday 5 May 1992.
- 8.5 Delegates raised issues for purposes of clarification arising from the second report. Discussion of the report followed.
- 8.6 It was agreed that delegations would take the second report of the technical committee back to their principals for further discussion and feedback.
- 8.7 To avoid misinterpretation in the press, it was agreed that the report be released to the press with the explanation that it is a working document still to be discussed by the delegations. The SA Government and IFP delegations requested that their objections to the release of the document be noted. It was suggested by T Mbeki that delegates should avoid commenting on the document to the press and rather to refer questions to the Chair.
- 8.8 It was suggested by K Andrew that the MC be requested to examine means of ensuring that matters of defence and security are dealt with. He suggested that Working Group 1 be consulted on this matter.
- 8.9 The ANC proposed an additional clause concerning the State of Emergency for consideration by delegations.
- 8.10 P Gordhan noted that the matter of implementation and time frames has not been fully considered by the Working Group. Recommendations in this regard still need to be arrived at before CODESA 2. Delegations were requested to consider this matter when consulting with their principals.
- 8.11 VB Ndlovu proposed, J Scheepers seconded and the Working Group duly agreed that delegates communicate feedback on the second report of the technical committee from their principals CODESA or the Technical Committee members before Sunday 10 May 1992 when the next meeting of the Technical Committee will be held, the purpose of which would be to emerge with a third report to be presented to the Working Group for adoption at its next meeting and presented to CODESA 2 as its report.
- 8.12 The purpose of the next meeting of the Working Group will be to finalise its report to CODESA 2.

- 8.13 The Chairman in summary, reminded delegations that they were expected to discuss the second report of the technical committee with their principals before the meeting of the technical committee and communicate their views regarding:

- * Whether they are in favour overall of the nature of the proposed Transitional Executive Structure, or not, and
- * Which specific matters, including outstanding areas, are of concern and comments/suggestions thereon.
- * The chair also indicated that he could be telephoned or faxed with these comments for the Technical Committee's attention.

9. DATES FOR THE NEXT MEETING

The next and last meeting of Working Group 3 before CODESA Plenary Session 2 will be held on Monday 11 May 1992, 09H00 - 17H00.

10. MEDIA STATEMENTS FROM WORKING GROUP 3

There were no media statements from Working Group 3.

11. OTHER URGENT BUSINESS

- 11.1 L Mtshizana raised concerns regarding the press statement released on 4 May 1992 by the South African Government. S van der Merwe clarified that this press statement was in reference to Phase 2 of Interim Arrangements.
- 11.2 P Gordhan proposed that the chair be given the mandate to play a role in reconciling differences between political parties and organisations in the next week. This was accepted by the Working Group.

12. CLOSURE

The meeting closed at 12H30 on Wednesday 6 May 1992.
