MGENI SYSTEM ANALYSIS - PUBLIC INFORMATION MEETING

As a result of the growing population and associated water demands in the Greater Pietermaritzburg/Pinetown/Durban (PPD) complex, it will be necessary to develop new water resources in the foreseeable future. Currently, all water used in the PPD complex is supp lied

from the Mgeni River and its tributaries, with the possibility of utilising some water from the

Mooi and Mlazi Rivers if necessary.

In order to ensure that suitable water resources are reserved for utilisation when required to

meet the demands of all water users in the PPD area and surrounding region, it is necessary to

now plan for the future. The Department of Water Affairs and Forestry, in close co-operat ion

with Umgeni Water, have therefore initiated a study to address this issue. Consulting Engineers

BKS lnc. were appointed to carry out the study, which involved a detailed analysis of the water

. resources of the Mgeni and adjacent rivers.

As you will recall, a Public Information Meeting was held in Pietermaritzburg on 18 March 1993, at which the initial findings of this study were presented. A study is now almost complete and the consultants are in a position to make their final recommendations with regard

to the future water resources infrastructure development.

With a study of this nature, it is essential to ensure local authority and community involvement

before any decisions regarding possible future developments are taken. To provide the opportunity for all local planners and interested parties to meet and discuss various relevant

issues, a Public Information Meeting is to be held in Durban on Wednesday, 23 February 19
