Dear Walter,

Last time I visited South Africa in June, I described on the phone to you an anti-violence resolution the Africa Fund had worked to have introduced in the U.S. Senate with the help of Senator Paul Simon and others.

I am glad to report to you that by a unanimous voice vote, the United States Senate passed the Resolution SR301, on October 2. The resolution condemns the violence in South Africa and points to the South African security force involvement in instigating such violence.

This is the first time the U.S. Congress has voted on apartheid's violence. Dumisani Kumalo, our Projects Direct, worked hard to win 30 co-sponsors for the resolution, and I testified in the Senate for the resolution

The resolution passed despite an extensive lobbying campaign by South African Ambassador Harry Schwarz and active opposition from the U.S. State Department.

The resolution which urges the government of F.W. de Klerk to "take effective steps to end the violence and protect all South African citizens regardless of race, color, or creed," also calls on President Bush to prepare and transmit to Congress a report on the nature of the violence, the role of various participants in the ongoing carnage, and the impact of this violence on South Africa's transition to democracy.

As a next step in our 'Stop the Violence' campaign we plan nation wide church services on Human Rights Day, December 10th and a Week of Action in February, which is Black History month in the U.S.A. It would be fine not to have still to confront violence next February -- but from this distance the signs look bad.

We are eagerly looking forward to the November meeting which will give us all an opportunity to review broad strategies. I hope it will also provide an opportunity for us to meet with you.
