# THE TANGLED SKEIN

THE WAR against Iraq has many threads. Ambitions and deep-seated motivations are inextricably entangled, one with the other. Unravelling this tangled skein shows clearly that Iraq presented a heaven-sent opportunity for many different power blocs to solve their problems and to realise their ambitions.

A general silence regarding the essential enigmas of this conflict has been maintained. And this has made it very difficult for the man in the street to arrive at the truth, since he knows only what the U.S. military wants him to know (as one frustrated CNN reporter complained). It is vitally necessary for us to understand the big chess game that the internationals are playing.

# WORLDS IN COLLISION

It is of the greatest importance to stress that the Kuwaiti issue as such is not the real issue. One of the major issues is in fact the Islamic-Zionist conflict. No political argument, pragmatic calculation, or worldly considerations, will move the massive bodies of opinions called Islam or Zionism from their respective positions.

Not one single member of the American or British Cabinets seems to have the slightest idea of such factors which compel millions. They have only a vague idea that there is an Islamic fundamentalist movement and a vague idea that Zionism is a factor. But their grasp of the magnitude of those two movements is extremely hazy.

The Lyke Report<sup>1</sup> throws some light on the Islamic view: "We are trespassers in a neighbour's backyard. Due to Islamic faith, the oil they sold was to be paid in gold, which value was then to be invested for additional interest and the principal kept in lieu of the oil for their people, thus satisfying Allah's demand of not taking a non-renewable resource from the land without replacing it with another of equal value. With the barter investment agreement ending in June 1990, a major crisis began ... Kuwait failed to keep Allah's law and so Hussein's invasion of Kuwait was intended to force them to live up to these laws, and the U.S. government may be solidifying all Muslims behind Hussein in a Holy

War against Christians and Jews."

Tom Anderson<sup>2</sup> explains that "Israel's state ideology, Zionism, combines beliefs which make flexibility and compromise both dangerous and blasphemous. The secular half of Zionism says that maximizing Israel's

land holdings is the sine qua non of the survival of the Jewish people in the world. The 'ingathering' of the world's Jews -- to save them from inevitable future holocausts, according to Zionism -- makes it suicidal for Israel not to hold on to all the territory that it can grab.

"The theological half of Zionism says that it is a religious sin to withdraw from any territory ruled by the Jewish state. Israel's rabbis have so ruled.

That is why Israel's much advertised and widely assumed desire for peace with its neighbors turned out to be a forgery."

# BUILD-UP TO THE WAR

We recapitulate here the more important aspects, some of which will be known to readers.

It must first of all be borne in mind that Iraq had been feuding with Kuwait for 30 years over the British-drawn border that separated their overlapping oil-fields. It was relatively easy to manipulate Saddam Hussein into invading Kuwait, so that invasion could be used to justify war against Iraq, skyrocketing oil prices, and the establishment of a New World Order.<sup>3</sup>

The story of how U.S. Ambassador April Glaspie and her boss John Kelly tricked Iraq into invading Kuwait<sup>4</sup> is already well known, as are Margaret Tutweiler's state-

# MANDELAMANIA ON THE WANE

SOUTH AFRICANS know the truth about Nelson Mandela and his ANC. What is interesting is the growing disillusionment in South African Establishment circles and independent sources abroad with the man that Jani Allen called the 'Chocolate Redeemer'. We give a few samples of this volte face.

**NELSON MANDELA** sees no irony in driving a Mercedes, while urging Germany to honour sanctions against Pretoria.

No individual is more hated by the ANC than Zulu chief Buthelezi. The ANC is primarily Xhosa, and never mind that Buthelezi campaigned relentlessly over the years for Mandela's freedom when he was imprisoned. The ones the ANC despise and seek to kill or repress are the Zulus of Chief Gatsha Buthelezi, who has done more than any black on the continent to undermine and weaken apartheid.

MANDELA cannot claim to represent a majority of South Africa's 29 million blacks. His power base is among the Xhosa people, who number around 3 million -- compared with 6 million Zulus and five million Whites.

IT IS A PITY the NP government lacks the courage of Tamsanqa Linda, a Xhosa like Mandela, who told American audiences that the ANC did not represent all SA blacks. He threw a spanner into Mandela's heavily financed, high profile tour with his outspoken criticism:

"The ANC is nothing more than a front for the Communist Party in South Africa," he said. "Nelson Mandela is as much a hardline Communist as Fidel Castro. And if the US gives the ANC money, it will be promoting violence in SA ... It is beyond belief," the former mayor of Ibhayi told his American audiences in ten cities, "that the criminal, Mandela, could be viewed in America as some sort of hero. He is not a hero in my country. He is a militant Communist who pours gasoline on the embers of apartheid. We are frankly astonished to see Mandela, who calls for violence, terrorism and sanctions, being treated like a legitimate foreign dignitary. He is a criminal and should have been kept in jail. It was a mistake for State President De Klerk to have released him."

Linda told a Philadelphia radio talk show: "Mandela is not a friend of African blacks, but has terrorised them in order to silence their opposition to his violence. The ANC is against everyone in the local authorities in SA and they oppose me because I have always been an outspoken critic of violence."

Hailed by the Washington Times as Mandela's "negative advance man", Linda had harsh words not only for Mandela. He accused American President George Bush of "glorifying an unrepentant terrorist and his wife, Win-

nie, who calls for violence." He urged Mr Bush to warn the American people of the true character of the ANC and of its association with the SA Communist Party.

# THE SHAPE OF THINGS TO COME

INTEGRATION of Black pupils into White schools in South Africa has now commenced. This change has naturally been greeted with rapture by our integrationist media, which carries heart-warming little tales of how well Black and White children get on together.

As an example of the liberal idiocy now required of our teachers, consider the headmaster who is reported as saying, at the first multiracial assembly: "I am close to tears as I speak to you. It is a privilege to welcome all the newcomers to our family." He has some rude shocks ahead of him.

Some parents, at least, are having doubts about the wisdom of what they have allowed to happen in our schools. In spite of a stream of reassuring pabulum in the media, it is clear that all is not rosy in the integrated schools. Many parents must be anxious to know what the future holds.

Actually, we know exactly what the future holds; for it has all happened before in other countries.

### A PICTURE OF HELL

For a picture of the hell lying ahead of our children we have but to study a booklet entitled "How class-room desegregation will work" by Dr Henry E. Garrett, Ph.D. (Patrick Henry Press, Richmond, Va., USA), which has been reprinted seven times. So far as we know, none of Dr Garrett's conclusions have been challenged, let alone shown to be wrong. Dr Garrett wrote the booklet "to give parents and teachers a clear look at what they may expect from school desegregation."

The booklet considers three studies: The Florida Study, The Georgia Study, and Project Talent. In case anyone wishes to charge the author with bias, it is worth pointing out that two of the three studies considered were commissioned by the Federal Government of the USA. It is certain that the White race has no more deadly enemy than the US government, although the British and South African governments are not far behind.

# THE FLORIDA STUDY

This study tested the intelligence of 1800 Negro school children, aged 5 - 14. For purposes of comparison with White children, the findings of the Florida Study are matched with similar findings for 3000 White children, made by Drs Terman and Merrill. It then appeared that:

- (a) The average IQ of the Negro children is 80.7. The average IQ of the White children is 101.8.
- (b) 5% of the Negroes achieved IQs above the average White child. Conversely, 89% of the White children achieved IQs above the average Negro child.
- (c) In the High-Average and Superior Groups are found 31% of the White children and 1.1% of the Negro children. Many of the Negroes found in this group have White ancestry, that is, they are what South Africans would call Coloureds.
- (d) In the Average or Normal Group are 46.5% of the White and 19% of the Negro children.
- (e) The Borderline and Defective Groups contained 8.22% of the Whites and 50.2% of the Negroes.
- (f) The average Negro pupil (whose IQ is 80.7) cannot go beyond a 7th Grade curriculum (Standard 5 in South Africa). For half the Negro group the 5th Grade is the maximum.
- (g) Only 1% (110 IQ and above) of the Negroes are intellectually equipped to do acceptable college work.

The authors of the Study summarise their results and conclusions as follows:

"Racially-mixed classrooms pose for the school administrator a choice between these alternatives: He can set standards to the Negro level, in which case 75% of the White children will work below their capacity, with resultant inferior education. Or he can adjust standards to White levels; in which case 75% of the Negro children will fail, drop out or become problems demanding special attention."

### THE GEORGIA STUDY

The IQ results of this Study repeat almost exactly those of the Florida Study. The Florida Study reported the average IQ of Negroes tested to be 80.7; that of the Whites to be 101.8. The Georgia Study shows the average IQ of tested Negroes to be 80. For Whites it is 103.

This study is in two parts. The first reports the pattern of intellectual and educational growth over a period of six years for more than 800 White and Negro pupils. The same children were tested four times: in the 5th, 6th, 8th and 10th Grades. Over this six-year period Negro-White differences in reading and arithmetic increased from two years at the 6th Grade level to three years or more at Grade 10. The gap between Negro and White children widened with the increase in Grade standing.

The second part of this Study shows that the Grade gap in the 8th Grade was 2.1 (Whites 7.7; Negroes 5.6). In arithmetic the gap was 2 (Whites 8; Negroes 6).

In the 10th Grade the reading gap was 3.2 (Whites 9.6; Negroes 6.4). In arithmetic it was 3.1 (Whites 9.5; Negroes 6.4).

The authors summarise their results by pointing out that lowering standards to accommodate the Negro pupils would deny the White pupil his maximum potential. It would also have the effect of nullifying attempts to strengthen education at all levels. They conclude that the sensible alternative is to maintain two levels of instruction, and to apply differential marking systems to the two groups. This would provide the best teaching and learning situation for both Negro and White pupils. This is precisely the system that worked so well for so long in South Africa and, for that matter, in the USA.

# PROJECT TALENT

This was a nation-wide comparative survey of the educational achievement of White and Negro children undertaken for the US Government by the University of Pittsburgh. 773 high schools and about 500 000 pupils were studied.

The authors summarise essential trends as follows:

- 1. There is a strong tendency for average test scores to **decrease** as the percentage of Negroes **increases**. The fall-off holds for all schools, and occurs in both non-verbal (abstract reasoning) tests, and in verbal (reading comprehension) tests.
- 2. The larger the percentage of Negroes in school, the higher the drop-out rate.
- 3. Absenteeism increased as the percentage of Negroes increased; also per-pupil expenditure. It costs more to operate an integrated school than a comparable segregated school.

South African parents should note this with care. Not only will their political cowardice by allowing school integration to come about, ensure that their children will receive a defective education -- it will also cost them more.

The authors point out, "The patrons of a newly desegregated high school can look forward to lower academic performance, more drop-outs, greater incidence of absenteeism, higher costs, and fewer graduates going to college. This will occur in direct proportion to the number of Negroes enrolled. Delinquency also increases as the percentage of Negroes rises."

# UNFAIR TO BLACK AND WHITE

To bring home to the abject South African parent just what his political flabbiness has done to his child, a few quotations from American teachers may be of interest:

"Race-mixing in the First Grade is the quickest way
to produce a Negroid culture." This will be music in
the ears of the ANC. It may be less popular in the
Platteland.

- "The bright pupils of my class are leaving."
  - "Virtually all social activities were abandoned after integration."
- "A class of mixed ability requires: for one race a maximum enrolment of 20; for mixed races 12."
- "Integrated schools are proving far more expensive than one-race schools."
- "It is painfully evident that desegregation and 'quality' education are incompatible."

Dr Garrett concludes by remarking that it is therefore "manifestly unfair to force the Negro child to compete against White students on White standards. This is the crime the integrationists are committing against the Negro, and it is a serious one." He continues: "It is manifestly and equally unfair to force White children to forgo their opportunities for quality education in order not to embarrass the slower-learning Negroes. Such educational 'breeding-down' can result only in cultural and educational disaster." We have been warned.

In his Inferno Dante told of the various levels of Hell: the lower the level, the more serious the crime and the more savage the punishment. One wonders what level and what punishment he would have deemed adequate for those White parents who force their children into the protracted Hell of integrated schooling, abjectly sacrificing them on the altar of politics. Whatever that punishment may be, one is permitted to hope that it will come soon, will be exemplary and that it will be prolonged.
