THE CRIMINAL SOUTH AFRICA INVASION AGAINST LESOTEO.
THE WAVE OF DESTRUCTION FOLLOWED THE PATTERNim
At Hahoohlo at the residence of one of our people, oomraie
Mathabathds a house was completely destroyed; imeeexplosion also
killed a 00w. A woman neighbour was shot dead when she peered
out through the window;
The next place for attack was Khena Flats where the SADF were
looking for comrade Chris's wife. They forced their way into a
neighbouring flat belonging to wr. Jerry Peko where they found
Miss 1matumo ralebitso, daughter of the Former Ambassador of
Lesotho to the peOplels Republic of Mozambique. Miss Ralebitso
in panic threw herself out through the window and died.
Another victim at Juena flats was one of our comrades who gallantly

put up an unsuccessful struggle against the attackers. He also attempted to escape through the windOw and died. (2 Died at Juena flats). At florida they bombed a Government house and killed four ANC members. They completely burnt one car (4dead)& At upper Thamae, they destroyed two houses belonging to Comrade Lehlohonolo Moloi. In one house, two people were burnt to death

and they have not yet been identified. A third person was shot dead. In a house next to Lehlohonolo's they killed eight people with gun shots and burnt one car. All eight alleged to be members of the ANC. One car was completely burnt and one house was damaged.

At Lekhaloaneng, Opposite Motaung's two houses were bombed. In one house three peeple died, all of them, Lesotho Nationals while in another house they killed three people, ANO (6 in all) dead. One car was damaged by bullets.

Comrade Chris' house at Lithabaneng was completely destroyed.

So far no indication of casualties in this house.

At a house near Motaungls towards qoaling there are four 90??989 in one house which have not yet been indentified.

At MohlalalitOe five peOple who are dead have not yet been identified. Our information is that a total of 40 people were muniered:

10 Lesotho Nationals (women and 3 Children) and 30 ANC refugees. Alfred Nzo.

THE LATEST INFORMATION WE HAVE CONCERNING THE

MASERU MASSACRE OF THE 9TH DECEMBER IS AS FOLLOWS,

Ian AT 13.00 HOURS DECEMBER 12, 1982.

A total of 41 peOple have been killed, 29 of whom are South African and 12 Basotho.

Of the 41 7 are women, 6 of them being Basotho and one a South African. There are four South Africans in Hospital. All of them are out danger. One of them is a young girl of about 8 years Of age.

The process of identifying the dead is not yet complete. The following is therefore a partial list these who have been identified.

Zola Nqini: Ex Robbeni Island prisoner, originally from Uitenhageo Phakamile MpongOShe: Ex;Robben;Ialand\_prisoner, originally frOm Port Elizabeth.

Jackson Tayo: Ex Robben Island prisoner, onoeroharged together with the late looksmart Soluandle who died while in police custody, originally from Lady Frere.

Ligwa Milankomo, originally from Port Elizabeth.

Kentrhdge Moloisane, originally from Bloemfontein.

Patrick Moholo, originally from the Bloemfontein.

Dumisani matandelay

Mbuso Bungaehe, originally from the Transkei (maluti).

Michael Mlenze.

Cecil Ngxitho, originally from Cofimvaba, Transkei.

Vhyani Zibi, originally from Mganduli, Transkei.

Samson Kana.

Sipho Notana, originally from Mdantsane, East London.

Lizethile Dyani, originally from Engoobo, Transkei.

Dr Norman Ngciphe, was visiting, having arrived a day earlier from Pietermaritzburgb

MZwandile Fazzie, was visiting, having arrived a day earlier from Duncan Village East London.

Titus Jobo, was visiting, having arrived a day earlier from the border area, Ex Robben Island Prisoner who has served about 18 years. Alfred Marwanqana, was visiting, having arrived a day earlier from Ilinge, Queenstown, Ex Robben Island Prisoner.

Thandiswa Marwanqana, Daughter to Alfred, was visiting with her father: The one South African woman who died.

Mzukisi Marwanqana, son to Alfred, was visiting with his father.

At this hOur of Grief for both our peoples, who are further united by the blood we have both shed, we extend our deep-felt condolences to Your Excellency, the government and people of Lesotho and request that your excellency convey these condolences to the relatives of the deceased Lesotho nationals.
