Style of work:

Oupa Mokou, the acting Chief Rep chaired the meeting. He made a comment on the wrong manner in which the office was run when Welile Nhlapo was a Chief Rep. whereby there were no regular meetings and that the office staff was working as individuals. The meeting agreed that all the past mistakes need to be corrected and a new style of work must be followed. The meeting decided that:

1. Staff meetings should be held twice a month.
2. Minutes of the past meeting should be distributed a day before the next meeting.
3. Staff members must constantly brief each other on new developments.
4. whenever one goes out, he must inform the others of where he is going to.

ANC Property:

Uupa requested to be briefed about the car that Nelile bought from Pankie Matebese since he was not informed about the deal.

George explained that a deposit of P2 000.00 was paid to Pankie. But when Welile finally took the car from Pankie and drove it to Johannesburg, George was not informed nor any other member of staff.

When Welile reached Jhb. with the car, he realised that the car was not road worthy. He then decided to give it back to Pankie. Pankie has not paid back the P2 000.00. Dupa objected very strongly for the fact that he was not informed and he asked to be distanced from the whole issue.

X A follow up by Dupa about the Corolla at the Police Station.

* BD 5335 D - George to ask Welile when is he going to bring back the car.

3 Ford Meteor - A report is expected from George on the exact transactions with Thibedi.

t Embassy car - George to give a report. The car was sold for P2 500.00 and a Deposit of P1 000.00 was paid.

3 Serge insists that he has paid a sum of R4 000.00 to welile for the Honda Ballade but that money has'nt reached the office. George to make a follow up.

I The Dukwe car that has overturned should be sold as a scrap, Dupa to handle that.

t A follow up by George on the car mentioned by Bogatsu.

. PLDTS/HDUSES:

+ Bontleng â\200\224 Rates were paid last December. Dupe will check with the council how much more should be paid.

+ Mogoditshane â\200\224 A suggestion should be made at HG that this matter should be handled by lawyers.

+ SACTU house - Cdes. Kay Moonsamy and John Nkadimeng had requested Dupa to lease the house, but since SACTU no longer exists, the feeling of the office is that HG should discuss with Cdes. Kay and John so that the house should be officially handed to the ANC. Presently Cde. Makopo's wife stays in the house.

+ Tombstones â\200\224 The Treasury department agreed with the office that there is need for tombstones on the graves of Comrades who died in Botswana. Welile and Johnny went to Zeerust to check on prices of the tombstone and found . it will not be worthwhile to buy from Zeerust but Rustenburg because they are Cheaper there. At the same time the office suggested that it will be much better if HG can decide on how much they are prepared to pay for each tombstone so that families of the deceased could decide on the type of tombstones they want and if it is more than what HG could pay, then they will pay the difference. The office will write a letter to H0 on that issue as soon as possible - Johnny will draft the letter.

DUKWE/REFUGEES:

Out of the 90 people in Dukwe, 30 have left the camp on their own to unknown destinations. 58 have registered for repatriation to RSA. 15 will be going for' MK military training. 6 disciplinary cases will remain in Dukwe and will no longer be under the care of the office. Repatriation to RSA take place on April 24, 1992.

30 South African refugees who are ANC members are presently studying in Botswana.
