Agenda: Briefing Comrade Jacky on the developments in this region.

Comrade Chief started by introducing members of the Admin. to Comrad Jacky and thereafter gave the floor to Comrade Bram who briefed Comrade Jacky on the following:1.a) Programme that Comrade Jacky was too follow for his visit.

- a) i) Visit to Clinic and Zapu House
- b) ii) General members meeting
- c)iii) Meeting with the Baduza grou (10)
- d) vi) Meeting with UNHCR/Government/OAU
- 2.b) Problems faced by office in relation to the process of repatriation
 - a) Attitute of the UNHCR(Lusaka)
 - i) Slow repatriation process of our people bu UNHCR whilst some others go in large numbers.
 - ii) Withhelding of relevant info. by UNHCR from us causing some people to leave criminal cases/acts behind.
 - iii) UNHCR claims to have never been informed of the deadline.
 - vi) UNHCR saying that chartered flights are expensive hence commercial flights.
 - v) UNHCR collaborating consciously/unconciously eg. the letter inquiring about a certian Toka who was in Angola was never shown to us but got it using other means. (also refer to minutes of meeting with UNHCR)
 - b) Problem of Students
 - i) Position of Ed. Dept. (HQ) not clear on students here or rather not clear about the isntruction issues by SGO. As a result the students are up in arms against office(lusaka) thinking that decision of ging home/deadline is coming from office.
 - ii) Ed. Dpt. (HQ) must try some means because students go to donors and are told that donors have given money to ANC and then they come to the office (Lusaka) running whilst money has been given to HQ and no budget for this region.

- iii) That it is better if the Ed. Dept. looks for placement at home for students or provide the necessary back-up funds.
- vi) A lot of money is owed to various institutions and are threatening to take legal action against the organisation.

c) General Membership

- i) There are groups of people who are afraid to go home saying afraid of Askaris and other being afraid of crimes they committed either against our people or against regime (criminal cases).
- ii) Some are saying they want to finish their courses first.
- iii) Vandalising of ANC PROPERTY BY some (eg clinic, Zapu House) and theft and Abreak-in's (eg. Alpha). Some do not want to hand-over ANC cars.
- vi) Some are taking cover saying they are students whilst they are not.
 - v) Some approached UNHCR to settle them in any county except SA which the UNHCR did not reveal to ANC but was asked.

d) Group of Ten

- i) That this group is demanding everything from the office saying that the ANC used them so it must maintain them.
- ii) They insist that they are not going home but wants to study.
- iii) They have threatened the Admin so many time and the office does not know what to do with them but worried by the fact that we are also human beings.
- vi) The incident at stores where they went to take food by force and one comrade was forced to fire warning shots trying to defend himself.
 - v) That they went to the police saying that the weapon does not have a licence and that the days of UNIP are over we cannot do as we like.
- iv) Have managed to rally most of the membership to their side and having also issued such statements as 'wishing the AWB/CP to win the Ref'.
- iiv) Gone around informing international orgs. and present government that the ANC is un-able to seek indemnity for them and want their case to be taken to the International Court of Justice.

e) Military

i) That the military (Menchecker) dismissed the letter of the SG saying that JM does not know that whilst on the other hand Comrade A (Lehlonolo) insists that Menchecker and the whole people who claim to be employed by military must go home.

In his response to the above raised matters Comrade Jacky said that the report from this region was discussed by President, Dep. President, himself, TG, SG and other people and the SGO wrote a letter which addresed all the above matters more especially the group of ten and it was felt that they should be expelled from the ANC but he felt that he should first come to see for himself

and assess the situation before the letter is sent. He then went further to address the following points:

a) UNHCR POSITION

That because of the difference in deadlines of ANC and UNHCR - the latter ends in August and the former in April. The UNHCR intends to stay in SA even after August so seemingly they are using repatriation as a tool to achieve that, hence the slow process. That the ANC told them that if they intend to stay that can be negotiatiated and ANC prepared to assist but must not use the exiles.

After receiving list from this side he went straight to the Justice Dept and was told that infact half of the people on that list have been cleared and the other half not having indemnisty documents. UNHCR needs to be asked as to what happened with the other form, in JHB (UNHCR) is saying that in the forms there is nowhere where one indicates his/her membership of ANC so it does not know which forms belong to the ANC. That he will give UNHCR phone of Johannes de Beer so as to sort out issue.

b) Students

That the REpatriation Desk at home has managed to find places for at a cost of . So there are many colleges at home. That if some students wants to remain here it must like in Zim. and UK where the sponsor provides evething for the students and no ANC involvement.

c) General Membership

That no one must be afraid to go home even such people as Victor of OPS is there and nothing happens to him. It is unfortunate that the ANC cannot involve itself in criminal cases eg. rape etc instead it will give evidence against such cases.

c) Group of Ten
During the time of filling forms for indemnity everybody was instructed to fill that all actions were carried on the instruction of the ANC and suppose to reavel everything. But the group did not tell everything as a result when he went to Pretoria for their indemnity he was told that they have been indemnified on 52 counts and when he asked about the other two was told that its murder and argued for it to be dropped since it was also carried whilst on duty. When the other one of murder was revealed it suprised him because the group killed one of their comrade but never told that to the ANC. It became difficult hence coming here in order to find out exactly who they killed and why. On the question of the group's behaviour in this region they cannot and will never hold the ANC as their hostage leadership is very angry with them and will be expelled if they continue with their behaviour.

e) Military

Since the ANC expects an interim govt. to be in place at the end of June an agreement has already been reached on MK that it will be placed under the interim govt. and will go home as a force and only there that one will decide whether he/she wants to remain in the army or not. That JM has said all people who claim to be MK in this region must go to Uganda as they will be provided with everything there but not here in Lusaka. Even some comrade from Angola were told to go to the camps so all must go if they are considerin g themselves as soldiers.

Pleadges

1. Address issue of people to ge back home and see who are through a list to come from Pretoria and from there to confront UN so that it can charter a plane.

Special Briefing

That there is a danger that we (ANC) will hit the headlines very soon due to some illegal activities by some of our members and even involving some people who are highly placed in the movement.

In Angola 2 comrades were arrested after a cheque book diasappeared from the office of the Chief Rep. The 2 revealed to the police that they told the book in order to pay themselves because Ilovo hadegone to SA with some diamonds and came back with R130.000 in order that it could be shared between the four of them including the Chief Representative, Chief Rep. double crossed them and that is why they stole that cheque book. There is danger now since the 2 will appear in court very soon and might reveal what they revealed to the commission and Chief Rep was told to remain in Johannesburg.

Also sometime back 2 comrade were killed there also involved in diamonds smmuggling and were killed by a certain Portugues connected to the Chief Rep. That a certain women by the name of Fatima is fearing for her life due to the fact that she revealed some ANC members involved in these acts.

That people mostly ANC members are trufficking cars from home to Zambia and Angola in turn take diamonds and mandrax home and come back with cars again. Now they take vans to Angola in exchange of diamonds.

Allegations are that even some of the people based here are highly involved in these activities. namely

- 1. Doctor Haggar McBerry who treats us at our clinic in the back-yard.
- 2. A certain Allen aos based here. Recently came from home but was not seen in Johannesburg.
- 3. And a certian Victor also involved.

The ANC is in trouble because these might very soon appear in the news papers
