RE:LOST ITEMS.

I hereby present my compliments to you and have the honour to inform you that upon Comrade Jules arrival in Lusaka we immediately commenced with the investigations on the above matter.

After collecting all the relevant lists (papers) from Hill & Delaiman we identified the following lists:

1. List of all items received from us by Hill & Delaiman.

2. " " " " which we retrieved which are as follows:-

a) One by Comrade Desmond Sithole (DAC).

b) " " " Thami Mngomezulu (formerly DAC).

c) " " Comrades Joe Cotton and Jules.

d) " " " Japhet Ndlovu (Chief Rep. Zambia) and Robert Mancini

According to records, there were two (2) fridges in Hill & Delaiman and there was no third one. One of the two fridges was sent to you by Comrade Joe Cotton and the other one (small Kelvinator) was retrieved by myself and Comrade Robert Mancini. The latest information we have received from Thami is that the small fridge belong to Comrade Mokoena.

In the past few days we have been trying to locate Thami in order to get more information and that is the reason why Jules has little bit delayed.

According to the above-mentioned lists, Hill & Delaiman never received heaters, rain coats and gumboots, meaning that the said items were lost between your house and them.

The items which Twere in your house (ie bedroom), Myself and Jules sent everything to you except the weapons which were sent to Africa Liberation Centre.

In reference to the Eight Thousand Rands (R8.000) alleged to have been paid to Hill & Delaiman by our people, Hill &.Delaiman does not have any knowledge of such a transaction to have taken place. They therefore requested that if we have any evidence in relation to the alleged transaction they will be glad if we submit to them the receipts.

It is therefore very difficult for me to argue with these people on something which does not appear on the list of the items sent to them on the 22/04/91 and the amount of money (Rands) paid to them without receipts.

Lastly, please find enclosed herein are the afore-mentioned lists which I do hope will go a long way in resolving this issue.
