Dear Mr. Mangezi,

As a followup of the visit of Mr. Christiaan van Krimpen to Mazimbu and Dakawa, in March and April of 1990, a delegation of the city council of Rotterdam is planning to visit these places in the beginning of February. This delegation, that is accompanied by Mr. Karel Roskam as our advisor, is very much interested in visiting these camps that in 1990 received some material support from the city of Rotterdam. Another reason for visiting Tanzania is the ANC Donors Conference, which we will attend.

Our visit was in principle agreed upon by Mr. Mohammed Tikly a few months ago when he was in Holland, but I also would like to inform you personally. Also, I would appreciate very much to be able to talk with you during our proposed stay.

.We informed the Donors Conference Office about our plan to visit the ANC camps on February 4 and 5, but they told us that a visit on February 5 is not possible.

Therefore, I would like to propose the following:

The mission arrives in Dar Es Salaam on Feb. at 10.00 hours (flight XL 567). Would it be possible for us to directly go to Dakawa and Mazimbu, and return in the afternoon of the fourth? They' will be staying in the Morogoro hotel. Would it be possible for the ANC to meet us at the airport and to arrange transport from the airport to Dakawa/Mazimbu? I hope I don't bother you with these questions, but the point is that we really are very much interested in the camps, and we feel it is worthwhile to take some time to visit them.

limited transport and accommodation facilities, and the need for
key ANC personnel from Mazimbu/Dakawa to attend the Donors
