

## MINUTES OF UNDERSTANDING

of meeting between SIDA and ANC

## CONCERNING

Routines in connection with Swedish visitors  
to Mazimbu and Dakawa

Time: March 17, 1988

Venue: Swedish Embassy, Dar es Salaam

SIDA informed the meeting about the numerous problems encountered during the last six months in connection with obtaining authorization to visit the ANC settlements at Mazimbu and Dakawa. The problems have now reached such a proportion that the SIDA management has become concerned and worried and therefore has initiated this meeting to take place.

ANC appreciated the problems and pledged to do its utmost to alleviate the same. After a lengthy discussions about how to act in order to solve this sensitive question in our cooperation, the following was decided upon:

1. SIDA (Dar es Salaam) will collect the following data about each person applying to visit Mazimbu and/or Dakawa:
  - a. Full name
  - b. Date of birth
  - c. Place of birth
  - d. Nationality
  - e. Passport No.
  - f. Place of issue
  - g. Date of issue
  - h. Date of expiry
  - i. Occupation or profession
  - j. Residential address
  - k. Date of and reason for visit.



2. SIDA (Dar es Salaam) will send the information under 1 above , not later than three (3) weeks before the start of any intended visit, by telex to ANC Dar es Salaam. ANC will immediately acknowledge receipt of the telex message. SIDA will further at the same time send the same telex information to SOMAFCO (Attention Maseko).
3. The under 2 above mentioned telex messages will by SIDA be given a number in consecutive order (starting with 1/88), which will facilitate communications and references.
4. ANC will immediately or soonest possible forward the contents of the message from SIDA in form of an official letter to the proper Tanzanian authorities.
5. ANC will continuously urge the Tanzanian authorities for quick response to the applications in question. ANC will further undertake to inform SIDA (Dar es Salaam) immediately upon knowledge of any approved application. In the unlikely event of no response when only three days remain before the applicant's scheduled arrival, ANC will inform SIDA in order to make it possible for SIDA to consider cancellation or postponement of the concerned trip or mission.
6. SIDA will put at ANC's disposal a vehicle (Toyota Landcruiser) to be used exclusively for transport of Swedish and other Nordic visitors to Mazimbu and Dakawa from and to the Dar es-Salaam International Airport. The vehicle will be registered as the property of ANC but marked with SIDA logos. A vehicle journal (log book) will be filled in continuously and kept in the vehicle.
7. SIDA will defray the costs for spareparts and major repairs, if needed, of the vehicle mentioned under 6. above. Running costs and regular maintenance will be the responsibility of ANC.



Overall responsible for the maintenance and proper use of said vehicle will be the Chief Administrator at Mazimbu (Tim K. Maseko). Only those persons being authorized by him may drive the vehicle.
