CONFERENCE DECLARATION

We, the representatives of the people of the East Rand, in our capacities as leaders of the ANC, SACP, COSATU, SANCO, SASCO, COSAS, SADTU, Religious organisations, s Business, Taxis, Unemployed, TIC, NICC, ANC Youth and Women's leagues, met in the Johannesburg Garden Court Holiday Inn, over the weekend of 2-4 April 1993, to chart a strategic approach to the de-humanising cycle of violence that has engulfed our communities in particular and our country in general.

The Summit took place against the background of great optimism amongst our people at the prospects of a peaceful transition to democracy, led by our

tried and tested tripartite alliance leadership. The summit also took cognisance of attempts by forces who seek to delay this transition and to weaken the liberation movement by all forms of violence visited on our leaders, activists and communities.

The Summit drew great inspiration in its deliberations from the rich experiences of our people in their different sectors, youth, women, teachers, business, taxis, civics, unemployed workers and political organisations, in dealing with the violence. PROGRAMME OF ACTION

EAST RAND TRIPARTITE ALLIANCE & MDF FORMATIONS PEACE SUMMIT.

2nd - 4th April 1993

The ERAP conference established 8 separate commissions to help develop a Programme of Action around the central issues of:

1. Taxis 2. Mass Democratic Movement (MDM) Structures 3. Crime 4. Self defence Units (SDUs) 5. Local Dispute Resolution Committees (LDRCs) 6. Business 7. Youth 8. Building Organisation 9. Food

The commissions developed a set of resolutions in each of the above areas which were then combined into the Programme of Action (POA) outlined below.

TAXIS:

A new structure must be set up to combat the violence on the roads.

Purpose:

1. To improve the safety of commuters using taxis.

Structure:

1. The organisation should have local, regional and national structures. Locally, representation should be from the civics, taxi associations, driver organisations, MDM forces, traffic departments, town councillors.

2. The size should not be more than 15 people, and it should be established by the last week of April.

3. On a zonal level there should also be smaller structures with representation from the local civics, taxi owners and drivers organisations, MDM formations and local traffic officers.

4. The size should also be about 15 people and should be formed by the 2nd week of May.

Activities:

1. Make all formations accountable for the carnage and monitor perpetrators of violence.

2. Educate all formations on the effects of violence through peace adverts, seminars, workshops, rallies etc.

3. Conduct a security programme to introduce safety measures.

4. Introduce a code of conduct for owners, passengers and drivers.

Process:

1. Mandate the local representatives to form the structure.

MDM Structure:

1. A summit should be held to address the education crisis and develop a common approach.

2. The conference should be held not later than the end of May.

3. Participants should include: ANC, COSATU, SACP, NECC, SADTU, SASCO, COSAS, and Civics.

4. A strategising meeting should be convened within 2 weeks - i.e. not later than mid April. The ANC should convene the meeting.

5. In addition there is a need for a regional summit for the Alliance and MDM. This should occur within 3 months and should deal with: - relations - a common programme of action, including an election strategy.

ANTI-CRIME:

Purpose:

1. To define new moral values and not just do policing.

Structure:

1. An anti-crime campaign to be based around the following slogan: "Safe localities for women and children"

2. Any action should be initiated by MDM structures as a focused attempt to address the needs of the most oppressed and affected in our locality. In the process, the campaign should be rationalised with other related initiatives.

Timing:

1. In May a meeting must be held to review progress in the establishment of the campaign.

Activities:

1. Educate the community through: - street meetings and setting up street committees - local mass meetings

2. Set up anti-crime coalitions through: - involving all interested and affected structures at local level, - involving the police while making sure

Purpose:

BUSINESS:

Purpose:

1. To improve the engagement of the local structures with the business community.

Different conditions in various localities dictate the urgency of the implementation of the resolution. Therefore:

1. East Rand level meeting of the Alliance and MDM to discuss the meeting with different business organisations on a bilateral basis to be convened in a month's time.

2. Anti-crime campaign committees to formulate policies as soon as possible in order to facilitate fruitful discussions when meeting business people.

3. Local alliance of MDM structures to start engaging their counterparts where applicable.

YOUTH:

Education:

Purpose:

1. Establish (where there are none) and strengthen the PTAs and PTSAs.

2. Fuse POA AND education desk with those of local EECs to popularise: (a) people's education, (b) an education charter campaign

3. Strengthen/build strong SRCs.

4. Bring education policy debates to the level of all youth/students and parents through NEPI.

5. Workshops/seminars to be used for youth development by local EECs and MDM

Activities:

3. Promote political tolerance amongst youth organisations.

Activities:

1. After 5 months the existing conference structure must meet to: (a) Review progress on the POA (b) Monitor progress (c) Follow up if needed.

Building Organisation:

1. Working Committees at both regional and sub-regional level should oversee the implementation of the resolutions and Programme of Action in conjunction with the monitoring structures proposed.

Guns Given To Renamo By SA Government Are Coming Back - Mbeki

JOHANNESBURG April 4 Sapa

Thousands of AK-47s imported by the South African Government to arm Mozambique's Renamo rebels were coming back into the country, African National Congress secretary for international affairs Thabo Mbeki said on Sunday.

A spokesman for the Department of Foreign Affairs has since denied Mr Mbeki's claims, SABC TV news reported on Sunday night.

Giving the closing address at the East Rand Peace Summit in Johannesburg, Mr Mbeki said the ANC was concerned about a South African repetition of the violence that had erupted in Angola after last year's elections.

More people had died there in the last seven months than in the previous 16 years of civil war, he said.

"The (South African) government imported thousands of AKs to arm Renamo. These are coming back to South Africa."

Mr Mbeki said the ANC was prepared to abide by the decisions of an election.

"We can do that because of the manner in which we behave. We can do that because of our programme of action."

The ANC was the only organisation that could lead the country into a non-racial and non-sexist society.

Organisations that had stayed out of negotiations had returned because they were not strong enough to stop the process, Mr Mbeki said.
