Members were generally concerned at the lack of response from ANC Tor. Views were expressed that this was a long-standing grevance on the part of members in Winnipeg.

REPORT OF ANTI-APARTHEID CONFRENCE Nov. 12/13/77

Neville reported that from his point of view the conference was highly successful and that Winnipeg had exceeded themselves in the physical arrangements. He expressed the opinion that Toronto seemed to have been remiss in their handling of the reps. from abroad. This should have been arranged way in advance and that visa trouble should not have prevented the reps from abroad from not being able to enter Canada. Good contacts had been established especially with delegates from the

west. These should be maintained. Was felt that ANC Wpg. should be fully informed about the happenings in

Toronto which prevented the Canada rep. from being present at the

Ray felt that security was not as tight as it should have been. How was it possible for Fatima to be approached by an outsider and questioned. How was it possible for Susan White to contact and lure away delegates

Was generally agreed that in future security should be the sole responsib of the ANC local when guests are from the liberation movements.

It was agreed that ANC Wpg Contact ANC Tor. because of concern about the outcome of the conference. Specific points raised by Dennis at the end of the conference should not be allowed to come to nought. It was also agreed that ANC contact CCSA in Wpg. to contact CCSA Tor. on the above issues

John suggested that CCSA Wpg send letters of thanks to certain people not attached to any organization, but who worked hard behind the scenes to make the conference the success that it was.

Was agreed that the proposal drawn up by Dennis & John should be made known to AAM members at the AAM AGM. Once accepted by AAM it should be sent to all affiliates of C CSA .
