Re: brief report on the recent ANCIUNDPIUNESCO monitoring missions

19/ 07/ 1993-Monday (Maputo ANC office)

Luguga, de Andrade-Diawara and myself met ANC officials in Maputo. All matters pertaining to student members of the ANC in the region (Maputo) were discussed. Ms. de Andrade-Diawara could not commit UNESCO on the issue of providing transport for the ANC students in Maputo. However she advised that the transport components provided by the UNESCO Study Grant for primary school pupils could be readjusted on request in accordance with the budget limits of the project. This will hopefully provide increased transport allowances for each child attending primary school in Maputo.

20/ 07/ 1993-Tuesday (Maputo International School)

Our delegation including ANC Maputo officials met Mr. Davis, the Headmaster of Maputo International School in his office.

The general performance of the children is satisfactory according to the Headmaster's reports though some of the children need some extra support to help them cope with ordinary scholarstic requirements. The Headmaster, Mr. Davis, informed us that he ms in the process of compiling an official and updated pedomance report on all ANC children in his school and that the reportwill be made available to us as soon as it was ready.

Our delegation met the head of ANC Education Department Cde. Samuels in his office

Comrade Samuels was also offered an invitation by UNESCO (Paris) to participate and contribute towards the forthcoming UNESCO conference with the invitation to be confirmed by UNESCO (Paris) in the near future. Since Cde. Masondo (ANC Chiei Representative-Uganda) amendend our meeting with Cde. Samuels, his input and contribution in the discussions of the meeting were crucial in that it also gave us some important information about the general education and training needs of ANC students in Uganda; which was on the itinerary of our monitoring mission. Only Luguga and de Andrade-Diawara met ANC Education officer in Zambia tde96avinmccording tc the report I got from Luguga, Cde Gavin was able to provide the delegation with most of the important information for the mission, and the delegation was satisfied with the general activities of the ANC/UNESCO/UNDP Educational Project in Zambia.

However problems of non-payment or school fees by our students were discovered UNESCO's final: official report on this mission will suggest solutions to the problems which were established in Zambia.

2 /06/ 1993 Monday (Kampala -Uganda).

The mission was able to visit some of the schools in Kampala and an audience was also held by the delegation with most of the ANC (SA) students (secondary school students) in the Chief Representatives office in Kampala. It is my considered opinion that the delegation was satisfied with the general students activities in Uganda. Cde. Neil Zumana and his education department's work in Kampala is commendable. All the students in Uganda are at all times in touch with the education department hence Cde. Neil's office was able to account for each - - student in the region.

About thirty (30) students are currently attending classes in various secondary schools in and around Kampala (Uganda). The general performance of these students in their various schools is quite satisfactory. It was therefore agreed that UNESCO Study Grant forms be dispatched to Kampala ANC office as soon as possible to facilitate payment of fees by UNESCO for all the students in secondary schools in the region.

It was also established that about 150 student members of the ANC were attending post-secondary and: professional education at various colleges in and around Kampala. Some of these students were on WUSU scholarships, which has indicated that it will terminate its assistance in the very near future. Therefore the ANC was advised by the delegation to request Comrade Chiliza (Am Chief Rep: Tanzania) to write a letter of request to the UNDP Resident Representative in Tanzania for the inclusion of these students (post secondary and professional) in the projects so that when the projects are revised in the next tripartite (TPR) meeting, these students could be considered for assistance.

UNESCO Fellowship Application Forms for post secondary and professional studies will be dispatched to Kampala ANC office as soon as possible to facilitate a process of getting the students considered for assistance by UNESCO.

UNESCO (Paris) delegation, de Andrade-Diawara, will make available, to all interested parties, an official report covering all the activities of this recently undertaken monitoring mission
