GRANT AGREEMENT

The Funding Committee of the Board of Fund for a Free South Africa, Inc. has approved a grant in the amount of \$131,842.31 to the Matla Trust, for support of projects facilitating the return of political exiles. Grantee agrees to the following conditions:

1. Grantee must expend the grant for charitable, scientific, literary or educational purposes and use the grant solely for the purposes in the enclosed cover letter. Grantee shall not use any portion of the amount granted which is not used for the purposes of the grant.
2. On or before February 5, 1992 grantee shall submit a report to grantor. Such report shall describe the progress that has been made toward achieving the purposes for which this grant was made and shall detail all expenditures made from the granted funds.
3. In order to receive the grant you must return the signed Grant Agreement to Fund for a Free South Africa within one month of issue date.
