

CAPE TOWN 2004 OLYMPIC BID CONVOCATION AND COMMISSIONS

Cape Town's bid to host the summer Olympic Games in the year 2004 is well advanced as a result of a major effort over the past six months in preparing the plans for sports facilities and infrastructure enhancements, and translating them into realistic budget figures. A comprehensive programme for the television and broadcast requirements is in hand. Task teams are working on the wide range of elements which hope to be covered comprehensively for inclusion in the Candidature File (commonly known as the "Bid Book"), which will represent South Africa's formal offer to host the Games and which has to be filed, with those of Cape Town's competitors, by August 14, 1996 at the offices of the IOC in Lausanne.

The full list of bidding cities for 2004 is Cape Town, Puerto Rico, Rio de Janeiro, Buenos Aires, Seville, Lille, St Petersburg, Stockholm, Rome, Athens and Istanbul.

The Bid is working closely with departments of the South African Government and the three tiers of government in the Western Cape to compile, match and agree the components of the Bid Book that relate to each of them. This process will continue through April and into May.

The Board of the Bid is now anxious to get in place the Convocation of the Bid which has been provided for in its Articles of Association and the three commissions to be created by the Convocation - Environment, Finance and Reconstruction and Development (RDP).

The function of the Convocation is to emphasise the national and Pan-African nature of our bid. It would inform important stakeholder representatives of the progress on the Bid, provide such representatives with an opportunity to discuss any concerns and to consolidate the support of Convocation members for the Bid.

The function of the Commissioners is to consider, evaluate and probe reports put forward to them by management, auditors or other parties of the Bid. Commissioners will be utilised in the following areas:

Environment - This commission will consider the impact of the Bid and its resultant operations on the build and natural environment.

Finance - This commission will act as an audit committee and consider the audit process and financial reports of the Bid.

RDP - This commission will consider the developmental impact of the Bid as well as its conformity with the principles of the RDP.

The patrons of the previous Bid Trust and the Board of Directors of the Bid are being invited by this letter to become members of the Convocation, as are identified key figures in South Africa, Africa and elsewhere. The Convocation will be invited to meet annually (or more often if required to discuss the Bid with the management) and offer its advice. Attendance at meetings will not be mandatory. The members of the Convocation have no responsibility to the Bid, the Board of Directors or the public and act strictly in an honorary and consultative capacity. No fees will be paid for membership of the Convocation.

The first meeting of the Convocation will be held at 09h00 on Tuesday April 2, 1996. The venue is the Banqueting Hall, 5th floor, Podium Block, Cape Town Civic Centre, 12 Hertzog Boulevard, Cape Town.

You are cordially invited to support Cape Town's Bid by becoming a member of the Convocation and responding to this letter advising of your acceptance, or by doing so at the meeting of the Convocation, or by faxing to fax number (2721) 21-6106 (International)/(021) 21-6106 (National).
