IT IS NO COINCIDENCE THAT THE DISSOLUTION OF THE CCR COMES ON THE EVE OF THE RE-COMMENCEMENT OF THE HARMS COMMISSION HEARINGS. THE MURDEROUS ACTIVITIES OF THE CCB. TOUSIDE AND OUTDIDE SOUTH AFRICA, ARE A MATTER OF GRAVE CONCERN TO EVERY SOUTH AFRICAN CITIZEN. IT IS THEREFORE VITAL THAT THEY BE THOROUGHLY INVESTIGATED BY THE JUDICIAL COMMISSION ESTABLISHED FOR THAT PURPOSE.

THE APPOINTMENT OF MAJOR-GENERAL LIEBENBERG, AS HEAD OF THE SADF.
UNFORTUNATELY, DOES NOT INSPIRE CONFIDENCE IN THE GOVERNMENT'S

THE ANC INSISTS ON THE RIGHT OF THE SOUTH AFRICAN PEO
POLE TO FULL AND COMPLETE DISCLOSURE OF THE EXTENT CCB'S STRUCTURE.
THIS OPERATIONS AND OPERATIVES, WHO HAVE BEEN RESPONSIBLE FOR SOME OF
THE MOST HEINOUS GRIMES COMMITTTED IN DEFENCE OF APARTHEID. WE
DEMAND THAT THE GOVERNMENT AND DEFENCE FORCE PERSONNEL WHO ESTABLISHED
AND COMMANDED THESE STRUCTURES BE CHARGED AND HELD ACCOUNTABLE FOR

THEIR CRIMES.
